Re: Broward County Bid PNC2119168P1 Continuing Engineering Services for Traffic Roadway and Civil Projects; Response to Objection by Calvin Giordano & Associates, Inc ("CGA") to LSN on Behalf of BCC Engineering, LLC, including Attestation of Additional Information.

Dear Ms. Billingsley:

This letter shall serve as a Response to the purported Objection filed by LSN Government Affairs on January 27, 2020 for consideration by Broward County Purchasing Division (the "County." This Objection should be rejected as both procedurally and factually inadequate.

I. MANDATORY LEGAL PREREQUISITES HAVE NOT BEEN MET.

1. LSN Government Affairs ("LSN") and BCC Engineering, LLC ("BCC") have failed to comply with the procedural requires of Procurement Code 21.84. There are 4 requirements; only three have been met (arguably). BCC has (i) identified itself through LSN as the vendor submitting an objection; (ii) articulated certain convoluted grounds for the objection, which will be addressed below; and (iii) identified the relief sought, the award. However, BCC failed to comply with the requirement that all objections shall contain *"a statement attesting that all statements made in support of the submission are accurate, true, and correct. The vendor shall acknowledge that the determination of inaccurate untruthful, or incorrect statements made in support of this submission may serve as a basis for debarment of the vendor regardless of whether the submission is directly provided by the vendor or a representative on behalf of the vendor."*

The *vendor* is required to make this attestation regardless of who is filing this submission. The attorney (here, LSN/G. Pratt) cannot make the attestation on these points for their client. This is consistent with the attorney's role in such matters; the attorney cannot be testifying. *See AlliedSignal Recovery Tr. v. AlliedSignal, Inc.*, 934 So. 2d 675, 678 (Fla. 2d DCA 2006) (citing FL ST BAR

Rule 4-3.7 ("Combining the roles of advocate and witness can prejudice the opposing party and can involve a conflict of interest between the lawyer and client.")).

In this instance, BCC has not verified anything – not that the statements are correct and not that the determination of inaccurate, untruthful, or incorrect statements may serve as a basis for debarment. Only LSN has "attested" – without notary, or other required indicia – and that was only to the statements being correct, although LSN has not stated that the signatory has first-hand knowledge to make such an attestation. Thus the Objection fails as non-compliant with 21.84 under the express provision of that section.

2. The Objector lacks standing. By its own admission, BCC is ranked third. BCC then mischaracterizes the Request for Proposals, which notes that the County may award "up to two" contracts, but does not state that it will. Thus, while the solicitation identifies the power of the County to award "up to two" contracts, there is nothing in the record to indicate its intent to do so. As the third-ranked vendor, BCC lacks standing to challenge CGA. See *Preston Carroll Company, Inc. v. Florida Keys Aqueduct Authority*, 400 So.2d 524 (Fla. 3rd DCA 1981) (applying substantial interest test).

II. EVEN IF BCC HAD MET THE MANDATORY PREREQUISITES OF ATTESTATION AND STANDING, THE KNOWN FACTS DEMONSTRATE THAT THE DECISION OF THE COUNTY WAS CORRECT IN ITS RANKING, AND IS NOT ARBITRARY OR CAPRICIOUS IN ITS ACTIONS.

Even if the Objection were compliant with 21.84, which it is not, the Objection fails on its merits. The ranking is entitled to remain so long as the interpretation of the solicitation documents and procurement code in its applicability in the rankings is not arbitrary and capricious, an analysis that is controlled by the Request for Proposal itself.

In this instance, the ranking is neither arbitrary nor capricious, and is solidly supported by earlier, consistent, interpretations by the county attorney regarding locality, by the documents submitted by CGA and by the lack of specific evidence that is relevant on their part.

BCC's alleged new evidence is neither new nor pertinent evidence, and several statements are inaccurate at best and misleading at worst:

1. The insinuation that CGA does not have its local headquarters in Ft. Lauderdale is wrong. CGA is a separate, distinct corporation from SAFEbuilt, and CGA has a local headquarters in Ft. Lauderdale, Florida, squarely meeting the intent of the locality rule – which is a geographical preference, not a local preference, under the procurement documents at issue here. (*See Bid p. 234*).
2. The statement that SAFEbuilt provides these same services, while also not accurate, is irrelevant to the question of whether CGA will be providing the

- services for which CGA bid, and for which CGA shall provide from its own headquarters in Ft. Lauderdale. Further, SAFEbuilt does not provide the same scope of services as provided by CGA. Specifically, SAFEbuilt does not house the expertise, engineers, qualifiers or principals with the experience required by the Broward County RFP documents.
3. The claim that U.S. Supreme Court's *Hertz* decision is not at all on point. In *Hertz*, the Supreme Court abrogated earlier opinions applying the analysis within federal statutes relating to diversity, which provides jurisdiction to the Court. Jurisdiction is required under Art. III of the constitution, and cases cannot be heard that do not involve federal law but are based on the diverse citizenship of the parties, again, under federal law. This analysis is completely inapposite to any analysis to be applied by the County in interpreting its own procurement rules and documents.
 4. CGA pays Broward County Local Business taxes. (*See* Broward County Business Tax Receipt at Bid p. 234).
 5. The CGA Certificate of Liability Insurance submitted for Broward County Bid PNC2119168P1 designates the Insured as Calvin, Giordano & Associates, Inc., 1800 Eller Drive, Suite 600, Fort Lauderdale FL 33316. Notably, it does not list SAFEbuilt as a Named Insured. (*See* Certificate of Insurance at Bid p. 258).
 6. The Board of Professional Engineers for Florida has issued a license to CGA – not SAFEbuilt – at CGA's headquarters on Eller Drive, in Ft. Lauderdale, Broward County, Florida. (*See* PE License at Bid p. 261).
 7. The State of Florida Department of Business and Professional Regulation Board of Landscape Architecture has issued a license to CGA – not SAFEbuilt – at CGA's headquarters on Eller Drive, in Ft. Lauderdale, Broward County, Florida. (*See* Landscape Architecture License at Bid p. 263).
 8. The Florida Department of Agriculture and Consumer Services has issued a Professional Surveyor and Mapper Business License to CGA – not SAFEbuilt – at CGA's headquarters on Eller Drive, in Ft. Lauderdale, Broward County, Florida. (*See* Mapper & Surveyor License at Bid p. 264).
 9. Since 2010, CGA has banked with Suntrust Bank, located at 515 E. Las Olas Boulevard, Ft. Lauderdale, Broward County, Florida 33301. (*See* Letter from SunTrust Bank at Bid p. 243).
 10. Numerous other official documents reflect Eller Drive, Ft. Lauderdale, as the headquarters for CGA. (*See generally* Bid). SAFEbuilt has nothing to do with the provision of these services at the location in Broward County in which CGA maintains its headquarters. The Department of State recognizes CGA as Florida corporation – not a Colorado corporation – organized under the laws of Florida. (*See* Department of State printout attached hereto as Exhibit A).
 11. Again, contrary to the rumors submitted as an Objection ("there is sufficient information that suggests CGA and SAFEbuilt share resources . . . and we have also learned that back- office, etc.") CGA herein attests that it has its own Human

Resources employee, IT employee, and Financial Services employee. Once again BCC attempts to be imputing and conflating – these are separate entities, and only CGA is responsible to the County on this submission, for this contract, and CGA is located, with its headquarters, in the County.

The following key personnel are located in CGA's headquarters in Ft. Lauderdale, along with IT, Human Resources, and administrative personnel:

- Dennis Giordano, President – reports to 1800 Eller Dr. in Ft. Lauderdale – current and only residence is located in Broward County.
- Chris Giordano, Vice President & Treasurer – reports to 1800 Eller Dr. in Ft. Lauderdale – current and only residence is located in Broward County.
- Curt Keyser, Vice President – reports to 1800 Eller Dr. in Ft. Lauderdale – current and only residence is located in Broward County
- Tammy Cook-Weeden, Vice President – reports to 1800 Eller Dr. in Ft. Lauderdale
- Steve Watts, Vice President – reports to 1800 Eller Dr. in Ft. Lauderdale – current and only residence is located in Broward County
- Dawn Hopkins, Secretary – reports to 1800 Eller Dr. in Ft. Lauderdale – current and only residence is located in Broward County
- Arelis Valero PhD, Director of Human Resources – reports to 1800 Eller Dr. in Ft. Lauderdale
- Robert Reyes, Talent Acquisitions Partner – reports to 1800 Eller Dr. in Ft. Lauderdale

Indeed, the documents submitted by the objector confirm that CGA is located in Ft. Lauderdale (*e.g.*, p. 40 of objection submitted by LSN/BCC and attached as Exhibit B demonstrating on the change of registered agent form appointing CT as a registered agent that the "principal office address" is 1800 Eller Drive, Suite 600, Fort Lauderdale, FL 33316). The location of SAFEbuilt is a red herring, and if the interpretation urged by LSN/BCC were adopted, the location would make no sense. For example, if the parent corporation was located in Ft. Lauderdale, but the office bidding on the project and performing the work was in Wyoming, the locality points would still be awarded to that entity because the parent company was in Ft. Lauderdale. Here, the County's interpretation of the solicitation is reasonable and the only logical

interpretation: where is the principal office of a distinct corporate entity that will be performing the work. This distinct corporate entity, CGA, is located and staffed in Fort Lauderdale, Florida. SAFEbuilt did not bid on this project and is under no legal obligation to perform services, as it is a separate corporate entity.

CGA is a separate entity under the law, and attributing the characteristics of the parent company merely because the parent company holds some portion of CGA stock would be inconsistent with applicable law. See *Gasparini et al v. Pordomingo*, 972 So.2d 1053, 1055 (3rd DCA 2008) ("A general principle of corporate law is that a corporation is a separate legal entity, distinct from the persons comprising them.") In order to conflate these two corporations, there must be some aspect of fraud; the separate identify of corporations is sacrosanct. *Ocala Breeders' Sales Company v. Hialeah, Inc.*, 735 So.2d 542, 543 (3rd DCA 1999). None is at issue here.

Accordingly, this Objection should not be considered as it was not properly attested, and if considered raises no new evidence of anything that would hold the County in arbitrarily interpreting its procurement documents. This is not a new question, and nothing in the record undermines the earlier legal opinion of the County Attorney's Office in applying the locality criteria. Indeed, the failure to adhere to this precedent, without cause, could itself be challenged. Further, BCC through LSN conflates local preference (which is not allowed) with locality – which is specifically required under the Procurement Code as a factor, and the conditions of which are met. CGA operates out of a local office, in Fort Lauderdale, Broward County, Florida, and thus is in close proximity to the Broward County public works department. Ultimately, CGA has a principal place of business in Broward County, which is reflected in the on Exhibit A, and which has been confirmed.

Past Projects In Broward

CGA has a long history with the community of Broward County. In fact, a large majority of CGA projects have been located in Broward County including *inter alia*:¹




