RESOLUTION NO.

1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD  
2 COUNTY, FLORIDA, AUTHORIZING APPROPRIATION AND DISBURSEMENT OF  
3 FLORIDA DEPARTMENT OF CHILDREN AND FAMILIES FISCAL YEAR 2026-2027  
4 GRANT FUNDS IN THE AGGREGATE AMOUNT OF \$1,085,268 TO SPECIFIED  
5 SERVICE PROVIDERS FOR THE PROVISION OF EMERGENCY SHELTER  
6 SERVICES, RAPID REHOUSING SERVICES, RENT PAYMENT ASSISTANCE, AND  
7 SUPPORTIVE SERVICES TO INDIVIDUALS AND FAMILIES EXPERIENCING  
8 HOMELESSNESS IN BROWARD COUNTY AND FOR ADMINISTRATIVE SERVICES;  
9 AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ALL NECESSARY  
10 ADMINISTRATIVE AND BUDGETARY ACTIONS TO IMPLEMENT THE GRANT AND  
11 AGREEMENTS WITH THE PROVIDERS; AND PROVIDING FOR SEVERABILITY AND  
12 AN EFFECTIVE DATE.

14 WHEREAS, the Florida Department of Children and Families (“DCF”) has awarded  
15 multiyear funding to Broward County under Unified Homelessness Grant Contract LP028,  
16 comprising the Emergency Solutions Grant, Challenge Grant, and Staffing Grant  
17 (collectively, “UHG Funding”);

18 WHEREAS, UHG Funding facilitates the development and implementation of the  
19 continuum of care plan and assists with the coordination and delivery of services that  
20 address the needs of individuals and families experiencing homelessness in Broward

21 County, including emergency shelter services, rapid rehousing services, rent payment  
22 assistance, supportive services, and administrative services (collectively, the “Services”);

23 WHEREAS, UHG Funding also supplements the cost of staffing expenses and  
24 administrative support to the Broward County Homeless Continuum of Care Board;

25 WHEREAS, the Board of County Commissioners of Broward County, Florida  
26 (“Board”), desires to appropriate and disburse UHG Funding to specified service  
27 providers for the provision of Services for DCF fiscal year 2026-2027 (“DCF FY27”),  
28 effective July 1, 2026, through June 30, 2027; and

29 WHEREAS, the Board finds that the Services to be funded benefit the residents of  
30 Broward County and serve a public purpose, NOW, THEREFORE,

31 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
32 BROWARD COUNTY, FLORIDA:

33 Section 1. The Board hereby authorizes appropriation and disbursement of  
34 UHG Funding for DCF FY27 in the aggregate amount of One Million Eighty-five Thousand  
35 Two Hundred Sixty-eight Dollars (\$1,085,268) as set forth in Attachment A.

36 Section 2. The agreements with the service providers identified with an “R” in  
37 Attachment A will be renewed for DCF FY27 in accordance with the terms and conditions  
38 of the agreements. The Broward County Administrator is hereby authorized to take all  
39 necessary administrative and budgetary actions to implement the grant and renewed  
40 agreements as set forth in Attachment A.

41 Section 3. Severability.

42 If any portion of this Resolution is determined by any court to be invalid, the invalid  
43 portion will be stricken, and such striking will not affect the validity of the remainder of this
