RESOLUTION NO.

1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, ACCEPTING A DONATION OF ONE HUNDRED TWENTY-FIVE
3 THOUSAND DOLLARS (\$125,000) FROM FRIENDS OF DEERFIELD ISLAND PARK,
4 INC., TO BE USED FOR DEERFIELD ISLAND PARK; APPROVING THE
5 DESIGNATION OF A SHUTTLE BOAT AS "JOANNA B."; AUTHORIZING THE COUNTY
6 ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE AND BUDGETARY ACTIONS
7 NECESSARY TO ACCEPT AND UTILIZE THE DONATION FOR THE STATED
8 PURPOSES; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

10 WHEREAS, Friends of Deerfield Island Park, Inc. (the "Friends Group"), wishes to
11 donate to the Broward County Parks and Recreation Division One Hundred Twenty-Five
12 Thousand Dollars (\$125,000) to be used for Deerfield Island Park;

13 WHEREAS, the Friends Group has requested, as a condition of the donation, that
14 one of the shuttle boats at Deerfield Island Park be designated the "JoAnna B."

15 WHEREAS, Section 18.63 of the Broward County Administrative Code requires
16 that donations to Broward County valued at Twenty-Five Thousand Dollars (\$25,000) or
17 more be accepted by a resolution of the Board of County Commissioners (the
18 "Commission"); and

19 WHEREAS, the Commission wishes to accept the generous donation from the
20 Friends Group, and to formally express its gratitude for the donation, NOW,
21 THEREFORE,

22 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
23 BROWARD COUNTY, FLORIDA:

24 Section 1. The Commission hereby accepts the generous donation of One
25 Hundred Twenty-Five Thousand Dollars (\$125,000) from the Friends Group, whose
26 address is P.O. Box 656, Deerfield Beach, Florida 33443. This amount will be deposited
27 into the Broward County Parks and Recreation General Trust Fund and used solely for
28 Deerfield Island Park, which purposes may include, without limitation, site improvements
29 and enhancements, removal of exotic vegetation, planting of native vegetation, general
30 maintenance, and installation of signage or benches. On behalf of the County and the
31 residents and guests who utilize the Broward County parks system, the Commission
32 expresses its gratitude for the donation.

33 Section 2. In accordance with the Friends Group's condition of the donation, the
34 Commission approves the designation of one of the shuttle boats at Deerfield Island Park
35 as "JoAnna B." The Director of the Parks and Recreation Division is authorized to take all
36 actions necessary to implement such designation.

37 Section 3. The County Administrator is authorized to take all administrative and
38 budgetary actions necessary to accept and utilize the donation for the purposes stated
39 herein and in accordance with the stated condition of the donation.

40 Section 4. Severability.

41 If any portion of this Resolution is determined by any court to be invalid, the invalid
42 portion will be stricken, and such striking will not affect the validity of the remainder of this
43 Resolution. If any court determines that this Resolution, in whole or in part, cannot be
44 legally applied to any individual, group, entity, property, or circumstance, such
