Compliance Comments:

BEA Architects, Inc., Bermello Ajamil & Partners, Inc., and Moffatt & Nichol submitted CBE Letters of Intent (LOIs) that met or exceeded the recommended 25% CBE goal with their proposals. Therefore, BEA Architects, Inc., Bermello Ajamil & Partners, Inc., and Moffatt & Nichol are in compliance with the CBE program requirements of the solicitation.

EXP U.S. Services Inc. initially submitted CBE LOIs totaling 16% CBE participation with their proposal. The submission was 9% below the 25% CBE goal recommendation for the solicitation. The firm was given three (3) business days to provide an increase to their CBE participation to meet the 25% CBE goal and/or provide proof of their good faith efforts. The revised LOIs were submitted within the required three-day period. Therefore, EXP U.S. Services Inc. are in compliance with the CBE program requirements of the solicitation.

Trachtenberg LLC initially did not submit CBE LOIs with their proposal. The firm was given three (3) business days to provide their CBE commitment on the required LOI form and/or provide proof of their good faith efforts. A LOI was submitted within the required three-day period. Therefore, Trachtenberg LLC are in compliance with the CBE program requirements of the solicitation.

CBE Compliance History:

The following is a report of the respondents' CBE compliance history for active and completed projects within the last five (5) years of the RFP opening date of October 13, 2021. OESBD cannot report CBE Compliance history of active projects for EXP U.S. Services, Inc. and Trachtenberg LLC as they do not have active projects with CBE requirements within the last five (5) years of the RFP's opening date.

In terms of project history, OESBD can report a CBE compliance history for BEA Architects, Inc., Bermello Ajamil & Partners, Inc., and Moffatt & Nichol of active or completed projects with CBE requirements exist within the last five (5) years of the RFP's opening date for these firms.
