Flagship Aviation Services, LLC submitted CBE Letters of Intent (LOIs) with their response package to use Ann's Janitorial Services, Inc for 10%; Dammel Cleaning Enterprise, Inc. for 10% and McKenzie's Cleaning, Inc. for 10% CBE participation totaling 30%. All of the aforementioned firms are CBE certified; therefore, Flagship Aviation Services, LLC is in compliance with the CBE program requirements of the solicitation.

GDI Services, Inc. submitted an LOI to use Ann's Janitorial Services, Inc., a CBE certified firm, for 30% participation with their response package and is in compliance with the CBE program requirements of the solicitation.

LGC Global Energy FM, LLC submitted LOIs to use Amer-Plus Janitorial Maintenance, LLC for 10%, Ann's Janitorial Services, Inc. for 10%, McKenzie's Cleaning for 10% and NAPM Enterprises, Inc. for 10% totaling 40% CBE participation. All of the aforementioned firms are currently CBE certified and LGC Global Energy FM, LLC is in compliance with the CBE program requirements of the solicitation.

LN Pro Services, LLC did not submit a Letter of Intent (LOI) with their response package. The firm was given three (3) business days to provide their CBE commitment on the required LOI form and/or provide proof of the good faith efforts. LN Pro Services, LLC submitted a Letter of Intent (LOI) to use JRB Services of SFL, LLC for 30% CBE participation within the requested time frame and is in compliance with the CBE program requirements of the solicitation.

National Aviation Services, Inc. dba The Facilities Group (TFG) Aviation did not submit a CBE Letter of Intent (LOI) with their response package. The firm was given three (3) business days to provide their CBE commitment on the required LOI form and/or provide documentation of their good faith efforts. At the end of the compliance evaluation period, the firm submitted an Evaluation of Good Faith Effort with no supporting documentation. Therefore, National Aviation Services, Inc., dba The Facilities Group (TFG) Aviation is not in compliance with the CBE program requirements of the solicitation.

SBM Management Services, LP submitted an incomplete LOI with their response package. The firm was given three (3) business days to provide their CBE commitment on the required LOI form and/or provide proof of the good faith efforts. SBM Management Services, LP submitted a revised LOI to use Amer-Plus Janitorial Maintenance, LLC, for 36.1% CBE participation within the requested time frame and is in compliance with the CBE program requirements of this solicitation.

Sunshine Cleaning Services, LLC dba Pritchard Industries submitted LOIs to use Dammel Cleaning Enterprises, Inc. for 10%; MCJ Professional Cleaning Services Corp for 10% and NAPM Enterprises, Inc. for 10% totaling 30% CBE participation. All of the aforementioned firms are currently CBE certified. Therefore, Sunshine Cleaning Services dba Pritchard Industries is in compliance with the CBE program requirements of the solicitation.

LN Pro Services, LLC and National Aviation Services dba The Facilities Group (TFG) Aviation submitted incomplete LOIs with their response packages. These firms were given three (3) business days to provide LOI forms, executed with CBE firms that meet at least 25% CBE participation and/or provide documentation of their good faith efforts within the required timeframe. These non-CBE firms responded within the required timeframe, and each provided executed LOIs with CBE firms that at least meet 25% CBE participation. Therefore, LN Pro Services, LLC and National Aviation Services dba The Facilities Group (TFG) Aviation are in compliance with the CBE Reserve requirements of the solicitation.

The firm was given three (3) business days to submit LOIs, executed with CBE firms reflecting at least 25% CBE participation or provide documentation of their good faith efforts to meet the 25% goal. The firm did not provide any additional information within the requested time frame. Therefore, 1 Lee Support Services, Inc. is not in compliance with the CBE reserve requirements of the solicitation."

Pursuant to Section 1-81.3(f) of the Broward County Business Opportunity Act (the "Act") on solicitations Involving reserves, "When a CBE reserve is established in connection with a County solicitation, CBEs and nonCBEs may respond to the solicitation. If a CBE with capacity to perform the work submits a responsive and responsible Bid or Proposal, the work will be awarded to the CBE that submits the lowest responsive and responsible Bid, or the highest- ranked responsive and responsible Proposal, subject to the conditions stated below (and consistent with all applicable terms and conditions of the County's Procurement Code and subject to entering into an agreement acceptable to the County).

The CBE with the lowest responsive and responsible Bid, or with the highest-ranked responsive and responsible proposal, as compared to all other CBEs (the "CBE Presumptive awardee"), shall be awarded the contract if the CBE Presumptive Awardee meets the following requirements, as applicable.

(1) Monetary Differential: The total Bid or Proposal amount of the CBE Presumptive Awardee: (a)(i) does not exceed Three Million Dollars (\$3,000,000) and (ii) does not exceed the total amount of the lowest responsive and responsible Bid, or the total amount of the highest-ranked responsive and responsible Proposal, as applicable, from a nonCBE by more than ten percent (10%); or (b)(i) exceeds Three Million Dollars (\$3,000,000) and (ii) does not exceed the total amount of the lowest responsive and responsible Bid, or the total amount of the highest-ranked responsive and responsible Proposal, as applicable, from a nonCBE by more than five percent (5%); and

(2) Points Differential: For competitive solicitations in which the Proposals are assigned point totals, after deducting the points awarded for price from the total points awarded to each applicable Proposal, the total points assigned to the CBE Presumptive Awardee: (a) for Proposals that do not exceed Three Million Dollars (\$3,000,000), are not more than ten percent (10%) less than the total points assigned to the highest-ranked responsive and responsible nonCBE; or (b) for Proposals that exceed Three Million Dollars (\$3,000,000), are not more than five percent (5%) less than the total points assigned to the highest-ranked responsive and responsible nonCBE.

If the CBE Presumptive Awardee does not meet the above requirements, as applicable, then the CBE with the next lowest responsive and responsible Bid, or the next highest-ranked responsive and responsible Proposal, as compared to all other CBEs, will be deemed the CBE Presumptive Awardee, and awarded the contract if the CBE Presumptive Awardee meets the above requirements, as applicable.
