Thank you for providing us with this information from the Planning Council regarding the LUPA under review for Monarch Hill Landfill.

We receive and review these groundwater monitoring reports from Waste Management as required by their existing operational Solid Waste License. If Waste Management desires to expand the landfill, they must submit an application to modify their Solid Waste License; that application must include a technical evaluation of this groundwater data. Our staff would review that technical evaluation to ensure the expansion of the landfill and any proposed operational changes conform to local, state, and federal law. One aspect of that evaluation is assurance that the expansion or modification will not cause degradation to the environment, whether it be through the introduction of contaminants or through the spread of any existing contamination identified throughout the landfill's history.
