# RESOLUTION NO.

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
 COUNTY, FLORIDA, APPROVING AND AUTHORIZING THE CONVEYANCE OF
 CERTAIN COUNTY-OWNED REAL PROPERTY LOCATED IN FORT LAUDERDALE,
 FLORIDA, TO THE FLORIDA DEPARTMENT OF TRANSPORTATION PURSUANT TO
 SECTION 125.411, FLORIDA STATUTES; AND PROVIDING FOR SEVERABILITY AND
 AN EFFECTIVE DATE.

WHEREAS, Broward County, Florida ("County"), is the owner of certain real property located in Fort Lauderdale, Florida ("Property"), as more particularly described in the legal description included in the Quitclaim Deed ("Deed") attached hereto and made a part hereof as Attachment 1;

WHEREAS, as part of the Broward County Convention Center expansion project,
the County applied to the Florida Department of Transportation ("FDOT") for a permit and,
as a condition of the issuance of said permit, FDOT requires that the County convey the
Property to FDOT for right-of-way purposes ("Stated Purpose");

6 WHEREAS, FDOT requires that the County execute and deliver to FDOT the Deed
7 conveying all of the County's rights, title, and interest in the Property;

WHEREAS, the Property is not needed for County purposes; and

WHEREAS, the Board of County Commissioners of Broward County, Florida
("Board"), has determined that conveyance of the Property to FDOT serves a public
purpose and is in the best interest of the County, NOW, THEREFORE,

22 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF 23 BROWARD COUNTY, FLORIDA:

Section 1. The recitals set forth in the preamble to this Resolution are true,
accurate, and incorporated by reference herein as though set forth in full hereunder.

Section 2. The Board finds that FDOT's proposed use of the Property for the
Stated Purpose promotes public or community interest and welfare.

28 Section 3. The Board finds that the Property is not needed for County purposes,
29 and the Property is required by FDOT for the Stated Purpose.

30 Section 4. The Board hereby authorizes the conveyance of the Property to31 FDOT.

32 Section 5. The Board hereby authorizes the Mayor or Vice-Mayor of the Board
33 to execute the Deed in the form attached hereto as Attachment 1.

34 Section 6. The Deed shall be properly recorded in the Official Records of35 Broward County, Florida.

If any portion of this Resolution is determined by any court to be invalid, the invalid
portion will be stricken, and such striking will not affect the validity of the remainder of this
Resolution. If any court determines that this Resolution, in whole or in part, cannot be
legally applied to any individual, group, entity, property, or circumstance, such
determination will not affect the applicability of this Resolution to any other individual,
group, entity, property, or circumstance.

### QUITCLAIM DEED

(Pursuant to Section 125.411, Florida Statutes)

Grantor and Grantee are hereinafter referred to collectively as the "Parties," and individually referred to as a "Party."

(The terms "Grantor" and "Grantee" as used herein shall refer to the respective parties, and the heirs, personal representatives, successors, and assigns of such parties.)

THIS CONVEYANCE IS SUBJECT TO all zoning rules, regulations, and ordinances and other prohibitions imposed by any governmental authority with jurisdiction over the Property conveyed herein; existing public purpose utility and government easements and rights of way and other matters of record; and real estate taxes for this year 2025 and all subsequent years.
