RESOLUTION NO.

1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD  
2 COUNTY, FLORIDA, APPROVING AND AUTHORIZING THE CONVEYANCE OF  
3 CERTAIN COUNTY-OWNED REAL PROPERTY LOCATED IN FORT LAUDERDALE,  
4 FLORIDA, TO THE FLORIDA DEPARTMENT OF TRANSPORTATION PURSUANT TO  
5 SECTION 125.411, FLORIDA STATUTES; AND PROVIDING FOR SEVERABILITY AND  
6 AN EFFECTIVE DATE.

8 WHEREAS, Broward County, Florida ("County"), is the owner of certain real  
9 property located in Fort Lauderdale, Florida ("Property"), as more particularly described  
10 in the legal description included in the Quitclaim Deed ("Deed") attached hereto and made  
11 a part hereof as Attachment 1;

12 WHEREAS, as part of the Broward County Convention Center expansion project,  
13 the County applied to the Florida Department of Transportation ("FDOT") for a permit and,  
14 as a condition of the issuance of said permit, FDOT requires that the County convey the  
15 Property to FDOT for right-of-way purposes ("Stated Purpose");

16 WHEREAS, FDOT requires that the County execute and deliver to FDOT the Deed  
17 conveying all of the County's rights, title, and interest in the Property;

18 WHEREAS, the Property is not needed for County purposes; and

19 WHEREAS, the Board of County Commissioners of Broward County, Florida  
20 ("Board"), has determined that conveyance of the Property to FDOT serves a public  
21 purpose and is in the best interest of the County, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
BROWARD COUNTY, FLORIDA:

Section 1. The recitals set forth in the preamble to this Resolution are true, accurate, and incorporated by reference herein as though set forth in full hereunder.

Section 2. The Board finds that FDOT's proposed use of the Property for the Stated Purpose promotes public or community interest and welfare.

Section 3. The Board finds that the Property is not needed for County purposes, and the Property is required by FDOT for the Stated Purpose.

Section 4. The Board hereby authorizes the conveyance of the Property to FDOT.

Section 5. The Board hereby authorizes the Mayor or Vice-Mayor of the Board to execute the Deed in the form attached hereto as Attachment 1.

Section 6. The Deed shall be properly recorded in the Official Records of Broward County, Florida.

Section 7. Severability.

If any portion of this Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution. If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Resolution to any other individual, group, entity, property, or circumstance.

**QUITCLAIM DEED**

(Pursuant to Section 125.411, Florida Statutes)

**THIS QUITCLAIM DEED**, is made this \_\_\_\_\_ day of \_\_\_\_\_, 2025, by and between **Broward County**, a political subdivision of the State of Florida, whose address is Broward County Governmental Center, 115 South Andrews Avenue, Fort Lauderdale, Florida 33301, hereinafter called "**Grantor**", and **the State of Florida Department of Transportation**, an agency of the State of Florida, whose address is 3400 West Commercial Boulevard, Fort Lauderdale, Florida 33309, hereinafter called "**Grantee**". Grantor and Grantee are hereinafter referred to collectively as the "Parties," and individually referred to as a "Party."

(The terms "Grantor" and "Grantee" as used herein shall refer to the respective parties, and the heirs, personal representatives, successors, and assigns of such parties.)

W I T N E S S E T H:

That Grantor, for and in consideration of TEN DOLLARS (\$10.00) and other valuable considerations, the receipt whereof is hereby acknowledged, does hereby remise, release, and quitclaim unto Grantee, its successors and assigns, forever, all of Grantor's rights, title, and interest, if any, in and to the following described lands, lying and being in Broward County, Florida, to wit:

See **Exhibit A**, attached hereto and made a part hereof ("Property").

**TO HAVE AND TO HOLD** the same together with all and singular the appurtenances thereunto belonging or in anywise appertaining, and all the estate, right, title, interest, lien, equity, and claim whatsoever of the said Grantor, either in law or equity, to the only proper use, benefit, and behalf of the said Grantee forever.

**THIS CONVEYANCE IS SUBJECT TO** all zoning rules, regulations, and ordinances and other prohibitions imposed by any governmental authority with jurisdiction over the Property conveyed herein; existing public purpose utility and government easements and rights of way and other matters of record; and real estate taxes for this year 2025 and all subsequent years.

A PORTION OF PARCEL "A", "PORT EVERGLADES PLAT NO. 2", ACCORDING TO THE PLAT THEREOF AS RECORDED IN PLAT BOOK 108, PAGE 31, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA, DESCRIBED AS FOLLOWS:

COMMENCE AT THE NORTHWEST CORNER OF SAID PARCEL "A"; THENCE NORTH 88°04'52" EAST ALONG THE NORTH BOUNDARY OF SAID PARCEL "A" AND ALONG THE SOUTH RIGHT OF WAY LINE FOR S.E. 17th STREET CAUSEWAY, A DISTANCE OF 656.89 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE ALONG THE LAST DESCRIBED COURSE NORTH 88°04'52" EAST, A DISTANCE OF 156.37 FEET; THENCE SOUTH 01°55'08" EAST, A DISTANCE OF 12.00 FEET; THENCE SOUTH 69°46'08" WEST, A DISTANCE OF 21.58 FEET; THENCE SOUTH 75°46'55" WEST, A DISTANCE OF 8.12 FEET; THENCE SOUTH 75°01'44" WEST, A DISTANCE OF 5.99 FEET; THENCE NORTH 14°18'04" WEST, A DISTANCE OF 13.02 FEET; THENCE SOUTH 88°07'27" WEST, A DISTANCE OF 89.24 FEET; THENCE NORTH 75°06'23" WEST, A DISTANCE OF 31.41 FEET TO THE POINT OF BEGINNING.

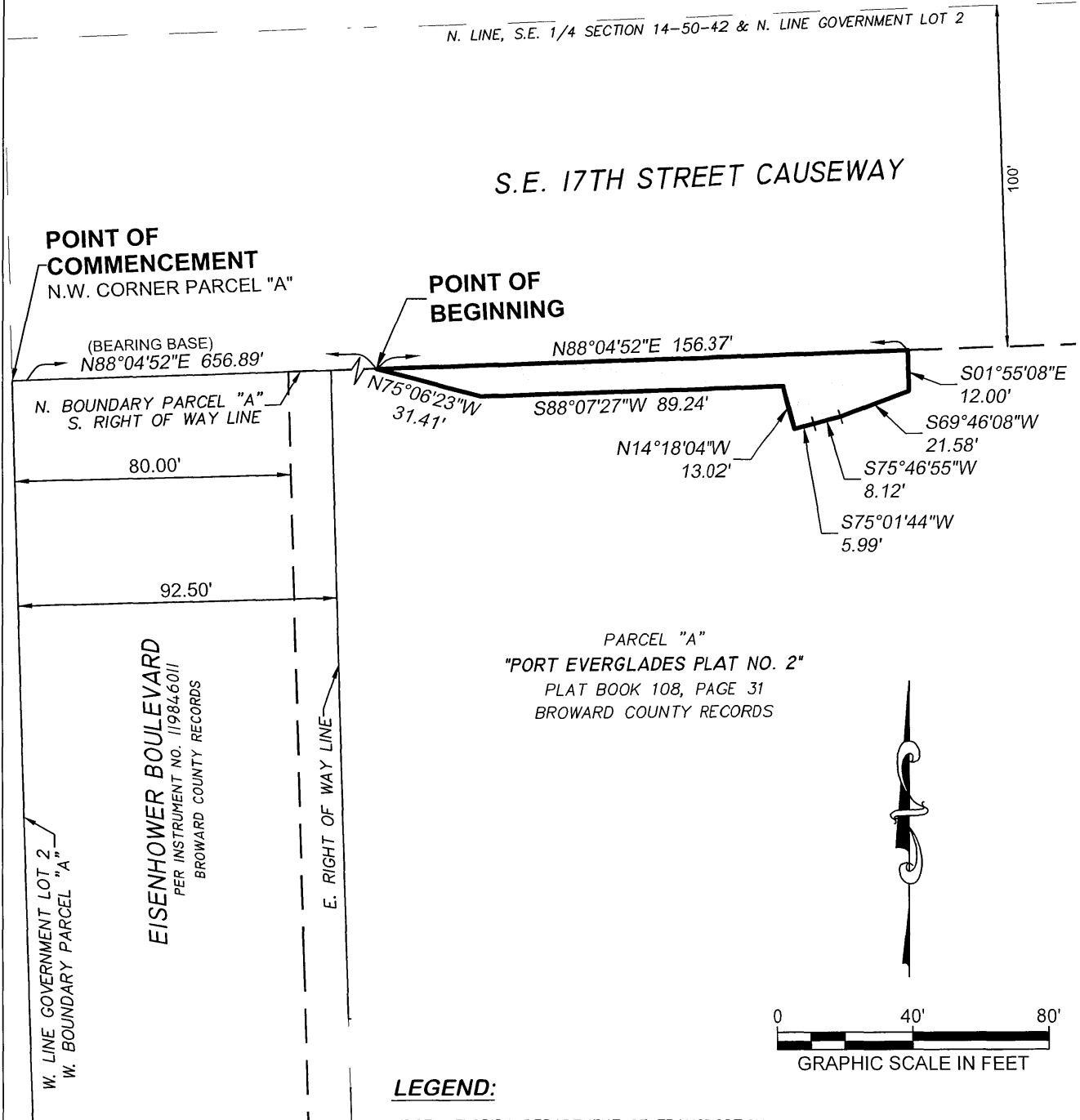
