1 AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, ADOPTING AN AMENDMENT TO THE ENVIRONMENTALLY
3 SENSITIVE LANDS MAP OF THE NATURAL RESOURCE MAP SERIES OF THE
4 BROWARD COUNTY COMPREHENSIVE PLAN WITHIN THE CITY OF FORT
5 LAUDERDALE; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

8 WHEREAS, Broward County adopted the Broward County Comprehensive Plan
9 on April 25, 2017 (the Plan);

10 WHEREAS, the Department of Commerce has found the Broward County
11 Comprehensive Plan in compliance with the Community Planning Act;

12 WHEREAS, Broward County now wishes to propose an amendment to the
13 Environmentally Sensitive Lands Map of the Natural Resource Map Series within the City
14 of Fort Lauderdale;

15 WHEREAS, the Planning Council, as the local planning agency for the Broward
16 County Land Use Plan, held its hearing on August 28, 2025, with due public notice;

17 WHEREAS, the Board of County Commissioners held its transmittal public hearing
18 on October 21, 2025, having complied with the notice requirements specified in
19 Section 163.3184(11), Florida Statutes;

20 WHEREAS, the Board of County Commissioners held an adoption public hearing
21 on February 3, 2026, at 10:00 a.m. [also complying with the notice requirements specified

22 in Section 163.3184(11), Florida Statutes] at which public comment was accepted and
23 comments of the Department of Commerce, South Florida Regional Planning Council,
24 South Florida Water Management District, Department of Environmental Protection,
25 Department of State, Department of Transportation, Fish and Wildlife Conservation
26 Commission, Department of Agriculture and Consumer Services, and Department of
27 Education, as applicable, were considered; and

28 WHEREAS, the Board of County Commissioners, after due consideration of all
29 matters, hereby finds that the following amendment is consistent with the State Plan,
30 Regional Plan, and the Broward County Comprehensive Plan; complies with the
31 requirements of the Community Planning Act; and is in the best interests of the health,
32 safety, and welfare of the residents of Broward County,

33 BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
34 BROWARD COUNTY, FLORIDA

35 Section 1. The Broward County Comprehensive Plan is hereby amended by
36 Amendment PCNRM 24-1, which is an amendment to the Environmentally Sensitive
37 Lands Map of the Natural Resource Map Series in the City of Fort Lauderdale, as set
38 forth in Exhibit A, attached hereto and incorporated herein.

39 Section 2. Severability.

40 If any portion of this Ordinance is determined by any court to be invalid, the invalid
41 portion will be stricken, and such striking will not affect the validity of the remainder of this
42 Ordinance. If any court determines that this Ordinance, in whole or in part, cannot be
43 legally applied to any individual, group, entity, property, or circumstance, such

44 determination will not affect the applicability of this Ordinance to any other individual,
45 group, entity, property, or circumstance.

46 Section 3. Effective Date.

47 (a) The effective date of the plan amendment set forth in this Ordinance shall
48 be the later of:

49 (1) Thirty-one (31) days after the Department of Commerce notifies Broward
50 County that the plan amendment package is complete;

51 (2) If the plan amendment is timely challenged, the date a final order is issued
52 by the Administration Commission or the Department of Commerce finding
53 the amendment to be in compliance;

54 (3) If the Department of Commerce or the Administration Commission finds the
55 amendment to be in noncompliance, pursuant to Section 163.3184(8)(b),
56 Florida Statutes, the date the Board of County Commissioners nonetheless

I. <i>Planning Council Staff Transmittal Recommendation</i>	<u>August 19, 2025</u>

Although Planning Council staff has not previously supported these types of amendments due to concerns regarding sea level rise, stormwater management and the protection of natural resources, including wetlands, staff does not object to the proposed amendment, recognizing the Planning Council's discussion and actions regarding similar applications at its May 22, 2025, meeting.

Further, staff suggests that any recommendation of approval recognize the restoration and preservation of the existing 1.68-acre natural area to the west of the site as a conservation easement, as well as the offsite mitigation.

As the Planning Council is aware, the Broward County Charter requires at least one Planning Council public hearing and Article 1.2(A) of the *Administrative Rules Document: BrowardNext* outlines the following circumstances in which a second Planning Council public hearing may be recommended or required:

- (1) At its initial public hearing, the Planning Council takes an action to recommend denial of a proposed amendment; or
- (2) At its initial public hearing, the Planning Council takes an action to recommend approval subject to meeting specific criteria or policy prior to a second Planning Council public hearing; or
- (3) At its initial public hearing, the Planning Council votes by a majority of the members present with a minimum of six (6) affirmative votes for a second Planning Council public hearing; or
- (4) If the County Commission requests by a vote of the majority of members present to request a second Planning Council public hearing; or
- (5) If an objection or comment on adverse impacts to important state resources or facilities is issued during the State of Florida Chapter 163 review process; or
- (6) If State of Florida Chapter 163 requires or is modified to require a second local planning agency public hearing.

If the Planning Council chooses to require a second Planning Council public hearing per Article 1.2(A)(1)(2) or (3), such recommendation must be made as part of its motion.

II. Planning Council Transmittal Recommendation August 28, 2025

Planning Council recommended approval of the proposed amendment to remove Site 66/ Map Label 83 from the Environmentally Sensitive Lands Map, recognizing the restoration and preservation of the existing 1.68-acre natural area to the west of the site as a conservation easement, as well as the offsite mitigation, including not requiring a second Planning Council public hearing. 


