

RESOLUTION NO. 2022/189

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DEERFIELD BEACH, FLORIDA, APPROVING AND AUTHORIZING EXECUTION OF A RECLAIMED WATER SUPPLY AGREEMENT WITH BROWARD COUNTY FOR THE CITY'S PURCHASE OF RECLAIMED WATER FROM THE COUNTY; PROVIDING FOR IMPLEMENTATION AND AN EFFECTIVE DATE

WHEREAS, reclaimed water is water recovered from domestic, municipal, or industrial wastewater treatment facilities that has been given a high degree of treatment and deemed safe for many non-potable water needs; and

WHEREAS, the proposed improvements to SW 10th Street by the Florida Department of Transportation ("FDOT") affords the City a unique opportunity to install a 12" reclaimed water main, and the City and FDOT have entered into a joint participation agreement for construction and maintenance of the reclaimed water transmission facility along SW 10th Street; and

WHEREAS, the City of Deerfield Beach (the "City") does not currently own or operate any treatment facilities for reclaimed water production or distribution; and

WHEREAS, Broward County (the "County") owns and operates the North Regional Wastewater Treatment System, which includes existing and planned future facilities for the supply of Reclaimed Water; and

WHEREAS, the County System includes the North Regional Wastewater Treatment Plant, which treats effluent to Reclaimed Water standards; and

WHEREAS, County operates or will operate Reclaimed Water facilities capable of serving the City's reclaimed water needs, and the City desires to purchase reclaimed water from the City to provide a source of non-potable water within City's service area; and

WHEREAS, the City desires to enter into the Reclaimed Water Supply Agreement, attached as Exhibit "1", (the "Reclaimed Water Agreement") with the County that provides for the City to purchase Reclaimed Water from the County.

WHEREAS, under the Reclaimed Water Agreement, the County agrees to provide the City's daily demand of reclaimed water up to 1.0 MGD, and the City agrees to purchase all of its reclaimed water from the County to meet the City's reclaimed water needs within the City's Service Area.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DEERFIELD BEACH, FLORIDA, AS FOLLOWS:

Section 1. The above referenced "Whereas" clauses are true and correct and made a part of this Resolution.

ON

Section 2. The City Commission hereby approves the Reclaimed Water Agreement with the County, attached as Exhibit "1".

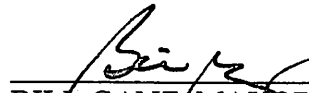
Section 3. The Mayor and City Manager are authorized to execute the Reclaimed Water Agreement, attached as Exhibit "1", together with such non-substantial changes as are acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 4. The appropriate City officials are authorized to do all things necessary and expedient to carry out the aims of this Resolution.

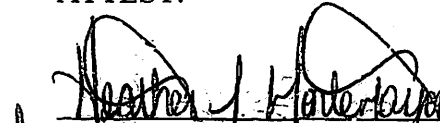
Section 5. This Resolution shall take effect immediately upon adoption.
