ORDINANCE NO.

1 AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, PERTAINING TO SPECIAL DISTRICTS; REPEALING
3 ARTICLES III AND IV OF CHAPTER 16 OF THE BROWARD COUNTY CODE OF
4 ORDINANCES ("CODE") RELATING TO THE NORTH AND SOUTH BROWARD
5 HOSPITAL DISTRICTS; REPEALING VARIOUS SECTIONS OF CHAPTER 30 OF THE
6 CODE RELATING TO THE CENTRAL BROWARD DRAINAGE DISTRICT, THE CORAL
7 SPRINGS IMPROVEMENT DISTRICT, THE PLANTATION ACRES IMPROVEMENT
8 DISTRICT, THE NORTH LAUDERDALE WATER CONTROL DISTRICT, THE NORTH
9 SPRINGS IMPROVEMENT DISTRICT, AND THE OLD PLANTATION WATER
10 CONTROL DISTRICT; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE
11 CODE, AND AN EFFECTIVE DATE.

14 WHEREAS, after the Broward County Charter was adopted in 1974, the Broward
15 County Code of Ordinances ("Code") incorporated and restated numerous preexisting
16 special acts of the Florida Legislature;

17 WHEREAS, the Florida Legislature has since repealed or amended certain of
18 those special acts pertaining to special districts in Broward County; and

19 WHEREAS, the Code provisions are therefore outdated and should be repealed,

20 BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
21 BROWARD COUNTY, FLORIDA:

22 Section 1. Articles III and IV of Chapter 16 of the Broward County Code of
23 Ordinances, pertaining to the North and South Broward Hospital Districts, are hereby
24 repealed in their entirety.

25 Section 2. Article IV of Chapter 30 of the Broward County Code of Ordinances,
26 pertaining to the Central Broward Drainage District, is hereby repealed in its entirety.

27 Section 3. Article V of Chapter 30 of the Broward County Code of Ordinances,
28 pertaining to the Coral Springs Improvement District, is hereby repealed in its entirety.

29 Section 4. Article VI of Chapter 30 of the Broward County Code of Ordinances,
30 pertaining to the Plantation Acres Improvement District, is hereby repealed in its entirety.

31 Section 5. Article VIII of Chapter 30 of the Broward County Code of Ordinances,
32 pertaining to the North Lauderdale Water Control District, is hereby repealed in its
33 entirety.

34 Section 6. Article IX of Chapter 30 of the Broward County Code of Ordinances,
35 pertaining to the North Springs Improvement District, is hereby repealed in its entirety.

36 Section 7. Article X of Chapter 30 of the Broward County Code of Ordinances,
37 pertaining to the Old Plantation Water Control District, is hereby repealed in its entirety.

38 Section 8. Severability.

39 If any portion of this Ordinance is determined by any court to be invalid, the invalid
40 portion will be stricken, and such striking will not affect the validity of the remainder of this
41 Ordinance. If any court determines that this Ordinance, in whole or in part, cannot be
42 legally applied to any individual, group, entity, property, or circumstance, such
43 determination will not affect the applicability of this Ordinance to any other individual,
44 group, entity, property, or circumstance.

45 Section 9. Inclusion in the Broward County Code of Ordinances.
46 It is the intention of the Board of County Commissioners that the provisions of this
47 Ordinance become part of the Broward County Code of Ordinances as of the effective
48 date. The sections of this Ordinance may be renumbered or relettered and the word
49 “ordinance” may be changed to “section,” “article,” or such other appropriate word or
50 phrase to the extent necessary to accomplish such intention.

51 Section 10. Effective Date.

52 This Ordinance is effective as of the date provided by law.
