HBH is entered into an agreement with BBHC effective July 1, 2022, which was later amended effective October 1, 2022. 	The Broward Behavioral Health Coalition (BBHC) has been granted the authority through the State of Florida Department of Children and Families (DCF) to contract with mental health providers for the purposes of providing temporary residential placement to individuals who are in crisis and have been deemed a danger to themselves or others. Because Henderson is the sole non-profit provider authorized through BBHC to provide these services throughout Broward County, the County is unable to utilize a different provider for Crisis Stabilization services. Additionally, the current Provider has a clear understanding of the population being served and maintaining this relationship would allow for the continuity of services and prevent any possible lapse.

Purchasing Agent Review

The Broward County Human Services Department is seeking to renew an agreement with Henderson Behavioral Health. Henderson Behavioral Health, Inc. is the only provider with a Crisis Stabilization Unit in Broward County. Such services include but is not limited to, twenty-four hour a day crisis services, case management for all ages, emergency, and permanent housing with support services for homeless people.

In accordance with Broward County Procurement Code, Section 21.5(b)(6), "Services provided directly to individual persons or families pursuant to County-administered or County-designated programs (such as behavior health programs or veterans services by the Human Services Department; or housing finance, minor home repair, or affordable housing services or programs by the Housing Finance Division)", these services are exempt from the requirements of the Procurement Code. However, a Request for Information GEN2126491F1 Crisis Stabilization Services was issued on May 1-8, 2023, which yielded no response. Further, a letter from the Broward Behavioral health Coalition contained a statement stating that Henderson Behavioral health Inc, is the only provider of such psychiatric crisis services (refer to Exhibit 1).

In accordance with the Procurement Code, Section 21.25(a) Purchasing Agent affirms that the required due diligence has been completed and recommends this most reasonable source designation. In addition, pursuant to Chapter 23- Operational Policy, Human Services, Section 23(d), and consistent with past practices, this recommendation is to allow the Human Services Department to proceed with an Agenda Item requesting the Board to approve the most reasonable source designation to Henderson Behavioral Health, Inc. to provide the requested services.

Section 23(d): "Single Source Determination is made by the Director or designee when the only known Organization and/or Professional Organization or the only reasonable Organization and/or Professional Organization is capable of providing a particular service or commodity to the County. All single source agreements require approval by the Director of the Purchasing Division and formal approval by the Board."

The annual amount is estimated at \$531,000 with a 5-year potential of estimated amount of \$2,655,000.

NOTICE OF INTENT TO DESIGNATE SOLE SOURCE/ONE REASONABLE SOURCE

The Purchasing Division is publishing this notice pursuant to the Broward County Procurement Code section, 21.25, Sole Source/Only Reasonable Source, and 21.26, Sole Brand. The Purchasing Division intends to award a contract without competition if it is determined to be in the best interest of the County. This is a Request for Information (RFI); it is not a request for pricing or a commitment to purchase.

Determination of Other Interested Vendors:

This Request for Information (RFI)/ Notice of Intent to Designate Sole Source/Sole Brand is intended to ascertain whether the commodity or service specified below is currently available from multiple providers/brands. The following products are thought to be available from only a single source/brand. Any such vendor must submit the following information:

- 1. The name of the interested party; and
- 2. A detailed explanation consisting of documentation showing that there are other qualified sources for the identified services herein.

Scope of Services/Background:

The Crisis Screening and Stabilization Unit (CSU) is the only 24-bed licensed psychiatric inpatient stabilization unit in Broward County that provides screening, assessment, treatment and stabilization of those individuals experiencing a severe emotional or psychiatric crisis who require a more restrictive setting. To ensure this critical service is available to the community, the County has funded services previously through our Sole Source/Sole Brand Request process.

Commodity/Service Required:

The County is seeking a licensed multi-bed psychiatric inpatient stabilization unit in Broward County that provides screening, assessment, treatment and stabilization of those individuals experiencing a severe emotional or psychiatric crisis who require a more restrictive setting.

If you are capable of meeting or exceeding the specification requirements for this product or equivalent, respond to this RFI/Notice of Intent to Designate Sole Source/Sole Brand through Periscope S2G.

Provide product literature via upload for any product to assist in determining if the product is comparable. The Director of Purchasing shall have sole authority in deciding what is comparable.

Broward County Board of County Commissioners

Prospective Vendors are requested to provide information regarding their ability to supply the commodities or contractual services described or written explanation or other documentation contesting the proposed designation as a Sole Source/Sole Brand. Prospective Vendors will be considered only if they provide documentation demonstrating that they are capable of meeting or exceeding the specification requirements stated herein.

All Vendor responses will be evaluated by the Director of Purchasing who shall have sole authority in establishing the approved equal status of the commodity or service offered by the vendor. The Director of Purchasing shall consider such submittals and notify all submitting vendors of the decision whether to designate as a Sole Source/Brand, which decision shall not be subject to objection, protest, or appeal.

Questions and Answers:

The County provides a specified time for Vendors to ask questions and seek clarification regarding the requirements of the solicitation. All questions or clarification inquiries must be submitted through Periscope S2G by the date and time referenced in the solicitation document (including any addenda). The County will respond to all questions via Periscope S2G.
