A RESOLUTION OF THE CITY COMMISION OF THE CITY OF PEMBROKE PINES, FLORIDA, APPROVING A MODIFICATION TO THE NON-VEHICULAR ACCESS LINE ALONG UNIVERSITY DRIVE AND PEMBROKE ROAD ON THE 'PEMBROKE PINES HEALTH PARK' PLAT, AS MORE PARTICULARY DESCRIBED IN EXHIBIT "A-1" AND EXHIBIT "A-2", ATTACHED HERE TO AND INCORPORATED HEREIN; DIRECTING THE APPROPIATE CITY OFFICIALS TO TAKE ANY AND ALL ACTION NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING FOR RECORDATION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Calvin, Giordano & Associates, LLC, on behalf of the City of Pembroke Pines, has requested a modification to the non-vehicular access line along University Drive and Pembroke Road of the 'Pembroke Pines Health Park' Plat, as more particularly described in **Exhibit "A-1"** and **Exhibit "A-2"**, attached hereto, and incorporated herein, to allow for the closing of the southernmost 80' wide Access Opening (prohibiting Left Turns Out) on University Drive centered at approximately 1,320' North of the centerline of Pembroke Road and the easternmost 50' wide Access Opening (restricted to Right Turns Only) on Pembroke Road centered at approximately 1,260' West of the centerline of University Drive; and

WHEREAS, the City's professional staff has reviewed the request to modify the non-vehicular access line along University Drive and Pembroke Road at the subject locations and recommends approval thereof; and

WHEREAS, the City Commission finds that approving a modification to the non-vehicular access line along University Drive and Pembroke Road is in the best interests of the health, safety, and welfare of the citizens and residents of the City of Pembroke Pines.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PEMBROKE PINES, FLORIDA THAT:

Section 1. The foregoing "WHEREAS" clauses are true and correct and hereby ratified and confirmed by the City Commission. All exhibits referenced herein and attached hereto are hereby incorporated herein.

Section 2. The City Commission of the City of Pembroke Pines, Florida, hereby approves the modification to the non-vehicular access line along University Drive and Pembroke Road on the 'Pembroke Pines Health Park' Plat, as more particularly described in Exhibit "A-1" and Exhibit "A-2", attached hereto, and incorporated herein, to allow for the closing of the southernmost 80' wide Access Opening (prohibiting Left Turns Out) centered at approximately 1,320' North of the centerline of Pembroke Road and the easternmost 50' wide Access Opening (restricted to Right Turns Only) centered at approximately 1,260' West of the centerline of University Drive.

**Section 3.** The City Commission of the City of Pembroke Pines, Florida, hereby directs the appropriate members of the City administration to send a letter of No Objection to Broward County and to take any and all other action necessary to effectuate the intent of this resolution.

**Section 4**. All Resolutions or parts of Resolutions in conflict herewith are hereby repealed to the extent of such conflict.

**Section 5**. If any clause, section, other part or application of this Resolution is held by any court of competent jurisdiction to be unconstitutional or invalid, in part or application, it shall not affect the validity of the remaining portions or applications of this Resolution.

**Section 6**. This Resolution shall become effective immediately upon its passage and adoption.
