Re: RFP PNC2128678P1 - Engineering Services for District 3A System Fire Flow Improvements Cone of Silence Violation Complaint Additional Sheet

To Whom it May Concern:

Shutts & Bowen LLP represents Thompson & Associates, Inc., Civil Engineering ("T&A") regarding RFP PNC2128678P1, Engineering Services District 3A System Fire Flow Improvements (the "RFP"). T&A is a local engineering company and Broward County certified CBE firm specializing in large utility projects with a long history of successfully completing projects for Broward County. T&A submits this narrative as an additional sheet to accompany its Cone of Silence Complaint pertaining to the RFP, and states the following as its grounds:

A. Summary

Chen Moore & Associates, Inc. ("CMA"), the recommended awardee as the first-ranked vendor for RFP PNC2128678P1, attached hereto as **Exhibit A**, through its employees, Amy Navarro and Vincent Locigno, PE, violated the Broward County Cone of Silence Ordinance 2022-11 by submitting a Dewatering Plan regarding District 3A System Fire Flow Improvements, falsely implying that it had already been awarded civil engineering services for this pending competitive procurement. *See* correspondence between CMA Staff and County staff attached hereto as **Exhibit B**.

B. Broward County Cone of Silence Ordinance

Pursuant to Section 1-266 of the Broward County Code of Ordinances ("County Code"), *Cone of Silence* means a prohibition on certain communication between certain persons regarding a particular competitive solicitation. *See* Sec. 1-266(a). As such the "Cone of Silence" applies to RFP PNC2128678P1 as a competitive procurement process. Per Sec. 1-266(c), the Cone of Silence shall begin upon advertisement of the Competitive Solicitation, and shall terminate the earliest of the following: the time the Board of County Commissioners ("Board") or other award authority (i) makes final award or approves the contract for the Competitive Solicitation, (ii) rejects all bids or responses to the Competitive Solicitation, or (iii) takes other action that ends the Competitive Solicitation.

1. Prohibited Communication

Sec. 1-266(b) provides that a Cone of Silence shall be in effect for all communications, oral or written, relating to a Competitive Solicitation at any point between the advertisement of the Competitive Solicitation and either the time the Board of County Commissioners or other award authority (i) makes final award or approves the contract for the Competitive Solicitation, (ii) rejects all bids or responses to the Competitive Solicitation, or (iii) takes other action that ends the Competitive Solicitation, between any of the following persons:

- (1) Any person or entity, including a Vendor or Vendor's Representative, that seeks a contract, award, recommendation, or approval for the Competitive Solicitation, or is subject to being evaluated, or having its response evaluated, in connection with the Competitive Solicitation; and
- (2) Any of the following: a Commissioner Office, County Staff, or a member of the Evaluation Committee for the Competitive Solicitation.

C. Cone of Silence Violation Narrative

CMA, the purported first-ranked awarded vendor for the RFP, has violated the Broward County Cone of Silence Ordinance through its employees Amy Navarro and Vincent Locigno, P.E. by communicating in writing with County Staff, including David J. Sheehan, P.E., Broward County Environmental Permitting Division. (We note that Mr. Sheehan's approval letter was directed to CMA President Peter Moore, P.E., but we have not seen if Mr. Moore had any communications, whether oral or written, with County Staff.)

1. Timeline of Events

On August 15, 2024, the RFP was issued. See Ex. A. Per section 1-266 of the County Code the Cone of Silence went in effect upon the advertisement of the RFP. On September 9, 2024, vendor proposal submittals for the RFP were due to the County. Dated October 18, 2024, CMA submitted a Dewatering Plan for District 3A System Fire Flow Improvements, a pending Competitive Procurement, signed and sealed by CMA employee, Vincent Locigno, P.E.. See Ex. B. Included within that Plan was an e-mail dated October 8, 2024, from Amy Navarro, CMA employee, contacted County staff, David Sheehan, seeking information for a contaminated site shown near Griffin Road and I-95 on the Courtyard Marriot Parcel, which ended up being included within CMA's Dewaterin Plan. Id. On October 9, 2024, County permitting staff, David Sheehan responded to Amy Navarro. Id. Valuable and detailed permitting information was sent to CMA regarding contaminated site historical data specifically for this project. On November 1, 2024, the County issued an approval for dewatering to CMA for Project ID 24285042, the project advertised in the RFP, attached hereto as Exhibit C. On November 4, 2024, Peter Moore, P.E., of CMA submitted to the County communication agreeing to the terms and conditions of the Dewatering Plan Approval Letter, see attached as Exhibit D. On November 5, 2024, County staff met for the presentations and ranking of firms for the RFP. In its written presentation on page 27 of 57, CMA

included the dewatering letter of approval highlighting that it was approved, though obtained in violation of the Cone of Silence. CMA's written presentation is attached hereto as **Exhibit E**. The inclusion of this approval status is important because as previously mentioned the permitting information was valuable as contaminated site historical data specifically for this project was included.

2. Language of Cone of Silence Ordinance Violated

Per the County's Cone of Silence Ordinance:

"[A] Cone of Silence shall be in effect for all communications, oral or written, relating to a Competitive Solicitation at any point between the advertisement of the Competitive Solicitation and either the time the Board of County Commissioners or other award authority (i) makes final award or approves the contract for the Competitive Solicitation, (ii) rejects all bids or responses to the Competitive Solicitation, or (iii) takes other action that ends the Competitive Solicitation."

Section 1-266(b), County Code.

The Ordinance further provides the following persons as prohibited from communicating with each other whether orally or through writing relating to a competitive solicitation between the date the solicitation is advertised and the date a county award authority takes an action that awards or ends the solicitation:

"Any person or entity, including a Vendor or Vendor's Representative, that seeks a contract, award, recommendation, or approval for the Competitive Solicitation, or is subject to being evaluated, or having its response evaluated, in connection with the Competitive Solicitation; and ... [a]ny of the following: a Commissioner Office, County Staff, or a member of the Evaluation Committee for the Competitive Solicitation"

Id.

Based on the Ordinance's clearly detailed prohibited communication provisions, the contact between CMA employees, Amy Navarro and Vincent Locigno, P.E., and principal Peter Moore, P.E., vendor representatives, and County staff, between the advertisement of the RFP (a competitive solicitation) and the time the Board of County Commissioners or other award authority makes a final award or approves the contract for the RFP, is a clear violation of the Cone of Silence.

3. *Unfair Competitive Advantage*

By contacting Broward County staff and coordinating their permitting questions while the Cone Of Silence was in effect, CMA gained a significant and unfair advantage over T&A because they were able to gain clear direction from Broward County staff on exactly how to move forward with the permitting process, as well as receive specific direction and insight on the dewatering permitting effort that is required for this project. T&A complied with the Cone of Silence ordinance and relied solely upon our experience obtaining dewatering permits on similar projects in Broward County when completing our RFP submittal and presentation to the Evaluation Committee.

The appropriate and typical timeline for submitting all permits for a project, including the dewatering permit, occurs at the 90% design phase. At this point in the design, the horizontal and vertical locations of the proposed infrastructure are known, and all comments from BCWWS staff have been adequately addressed. The dewatering permit is typically one of the shortest timeframes (normally 30 to 45 days) compared to other long-lead permits, as proven by CMA's ability to attain it in roughly 6 weeks. There is absolutely no reason to submit for a dewatering permit before a contract has been awarded unless that firm wants to gain a significant and unfair advantage over its competitor in order to win a contract from the County.

Furthermore, CMA does not have the authority to represent BCWWS and transmit signed and sealed calculations and specific project information to a permitting agency on behalf of BCWWS because they were not yet awarded the contract.

In addition, at no time did CMA disclose to County permitting staff that the submitted request for a permit was for a conceptual design related to an RFP that was not yet awarded. In fact, to the contrary, on page 2 of the CMA letter to Broward County staff dated October 18, 2024, CMA states, "Chen Moore and Associates (CMA) will be delivering civil engineering services for Broward County on the District 3A System Fire Flow Improvements project.". This statement is misleading, untrue, and an egregious attempt to gain a competitive advantage over T&A in the solicitation process.

CMA also presented plans, calculations, and site information based on a conceptual design. During Phase I — Preliminary Design, which contains land survey, geotechnical testing, and utility designation and coordination, information may be discovered regarding the existing site conditions, which alters the schematic design, rendering the permit issued by the County useless. As per Conditions 1 and 2 of the permits, dewatering has been approved and limited to the information presented by CMA. If any design changes are required to the conceptual design, CMA wastes the valuable time of Broward County permitting staff by reviewing a permit application for a project that has not even been awarded.

Contrary to CMA's unethical, dishonest, and unfair approach to this RFP, T&A followed every requirement of the procurement process and fully respected Broward County's Cone of Silence Ordinance.


