RE: **Proposed Modifications to Broward County Voting Precincts**

Through this memorandum, and pursuant to Section 101.001(1), Florida Statutes, I recommend that the Broward County Board of County Commissioners adopt the proposed adjustments to Broward County's voting precincts as represented in the enclosed new voting precincts map enclosed as **Exhibit A**.

After reviewing new data from the 2024 elections cycle, I identified additional precinct adjustments that I believe are beneficial to Broward County's electorate and in compliance with the requirements in Section 101.001, Florida Statutes. For the Board's convenience, the enclosed **Exhibit B** illustrates all proposed precinct adjustments, and **Exhibit C** illustrates the changes that specifically impact the nine County Commission districts.

Please let me know if I can answer any questions or be of further assistance in this matter.

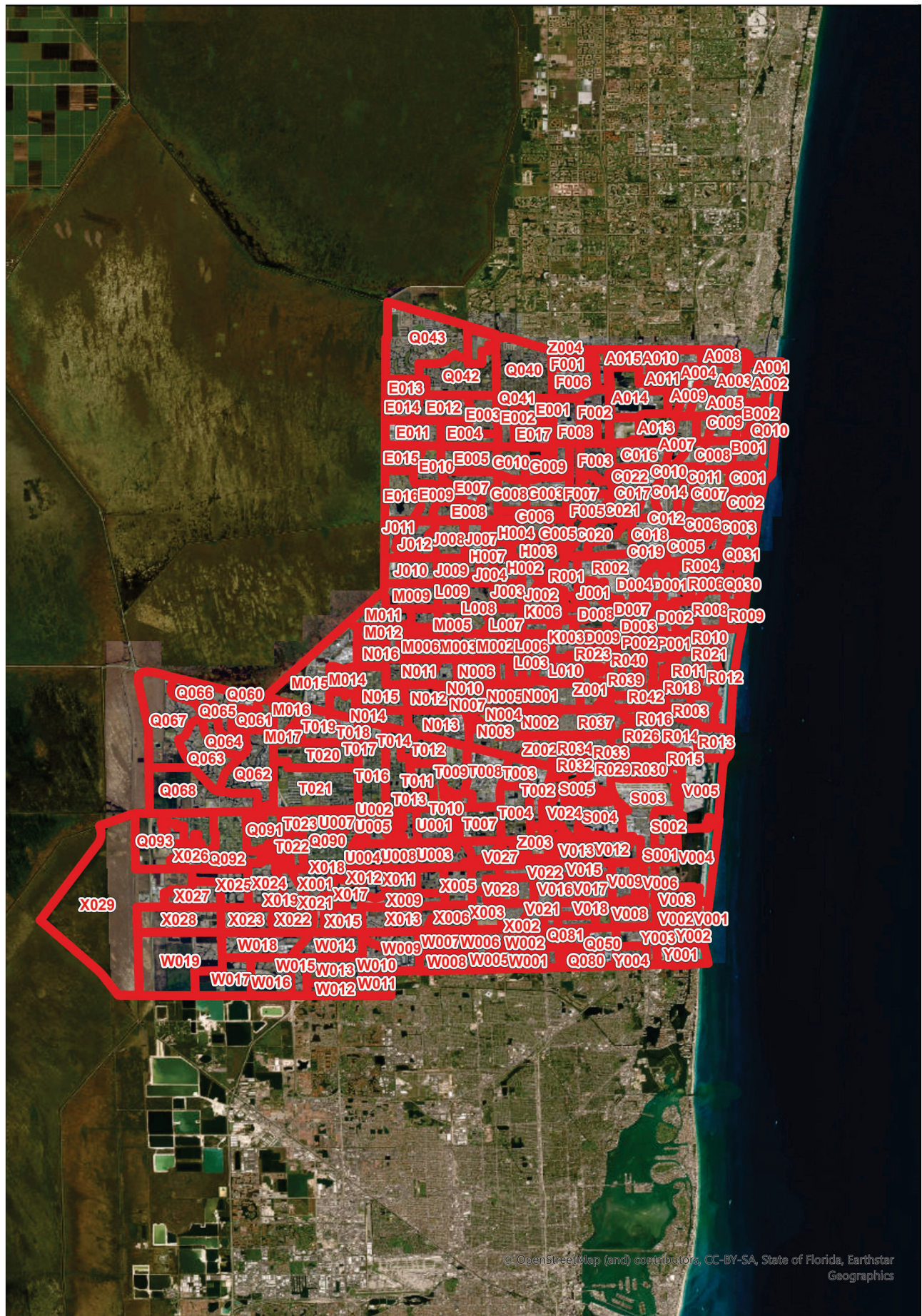
