

# **Alcohol and Drug Free Workplace**

Employees are the most valuable resource at Allied Universal<sup>®</sup>. For this reason, the company has a critical interest in the health, safety, and well-being of its employees and the maintenance of a safe and efficient work environment. The company recognizes that drug and alcohol abuse can be a key contributor to work environment safety and employee health problems. Drug and alcohol abuse can result in decreased productivity, judgment, and/or quality of task performance that may ultimately be a factor in increased accidents, medical costs, absenteeism and workers' compensation costs. Consequently, it is Allied Universal's goal to provide a workplace free of illegal drugs and alcohol abuse.

To accomplish this goal, the company tests all applicants following issuance of a conditional offer of employment, and reserves the right to test current Employees for reasonable cause, following involvement in any work related accident or injury when there is a reasonable possibility that drug or alcohol impairment contributed to the accident or injury, or on a random basis or annual basis, where permitted by law.

A verified positive test with no reasonable medical explanation will result in the conditional job offer of an applicant being withdrawn, and termination of employment for current employees. Submission to a drug test is a condition of employment, and refusal to submit to a drug test will be treated as though a positive test has occurred and the employee will be terminated unless otherwise provided by state law.

In addition to these testing requirements, the company will also enforce the following rules:

The manufacture, possession, use, purchase or distribution of illegal drugs or controlled substances, or paraphernalia associated with the same, is strictly prohibited on company (or customer) property, on company time, or while in company vehicles.

The use of alcohol by an employee on company (or customer) property, on company time, or in a company vehicle is prohibited. (Any exception for a company social function must be approved by a manager who is a Vice President level or above).

Reporting to work or working while intoxicated or under the influence of any unauthorized controlled substance or illegal drug is prohibited.

Any employee who is taking a prescribed or over-the-counter medication that may impact the employee's ability to perform the employee's job safely must immediately inform the Employee's Human Resources Representative.

All costs associated with the counseling and/or treatments are the sole responsibility of the employee, although counseling and treatment may be covered by an employee's medical insurance where available.

A decision to seek such assistance will not be used as the basis for disciplinary action and will not be used against the individual in any disciplinary proceeding. On the other hand, using a counseling or treatment program will not be a defense to the imposition of discipline for any previous or subsequent violation of the policy or rules listed above.



On March 23 an ILA worker was identified by Security of having someone else's Port ID and TWIC. He was denied entrance and hour later he was discovered in the luggage hall of the terminal. Security confiscated his TWIC and Port ID, and escorted the individual out of the terminal. When the incident was initially reported it was reported as Suspicious activity. After investigating it was discovered that the incident was a Breach and was then reported to NRC, three days after the incident occurred. As we were investigating, gathering information was difficult and we requested video footage from the Port to try and see where and how the ILA entered the Terminal, no video footage was found. And the investigation took a week to complete, which caused the information to be reported late to the USCG.

After the incident we submitted an amendment to USCG to implement wrist band policy for reoccurring access. Retrained all access control post. Implemented new policy for discovering failed TWIC policy all failed TWICs are now reported to BSO and Port ID is confiscated. Added a FSP post to a door that leads to the luggage hall.

The report types were mostly complaints and inspections, and six were accidents. All the report cases have been closed except two that remain open, one safety inspection dated 06/22/2023 in Los Angeles, CA, and one referral type dated 03/06/2024 in Washington, DC. The fines for these 40 reports totaled \$20,044.75.
