The Broward County Aviation Department, Maintenance Division (BCAD), strongly recommends rejecting the lowest bidder, ERMC Aviation, LLC (ERMC). ERMC is the incumbent provider, and BCAD has documented a continued pattern of performance failures over the past 32 months—issues that have persisted despite repeated interventions, escalations, and financial penalties.

Initially, ERMC's performance was satisfactory. However, after the first year of service, their performance deteriorated significantly, as reflected in multiple Vendor Performance Evaluations. Over the contract term, BCAD has engaged in near-weekly meetings with ERMC's key personnel, including its executive staff, to address ongoing performance deficiencies, review contractual obligations, and implement corrective action plans. Despite these exhaustive efforts, ERMC has consistently failed to meet the required performance standards, demonstrating an inability to improve.

BCAD has formally issued four (4) Notices of Non-Compliance to ERMC for failure to meet contract performance requirements. Additionally, BCAD has imposed over \$200,000 in financial penalties due to ERMC's repeated noncompliance. These penalties reflect serious and ongoing deficiencies in ERMC's ability to uphold contractual obligations and provide satisfactory performance. All documented performance failures are available for review in Contract Central.

Given ERMC's persistent underperformance, repeated contract violations, and significant financial penalties, BCAD has no confidence in this vendor's ability to:

- Properly maintain and repair the Airport's Baggage Handling System (BHS) equipment
- Communicate effectively and accurately with BCAD and stakeholders, especially during operational disruptions
- Provide complete, timely, and accurate reports and documentation
- Maintain an accurate parts inventory, which is critical to operational efficiency

For these reasons, BCAD cannot support awarding this contract to ERMC and strongly urges the Purchasing Director to reject this vendor.
