THIS AMENDMENT TO THE INTERLOCAL AGREEMENT REGARDING PORT EVERGLADES TRAFFIC SENSORS

("Amendment") is entered into this _ day of _____, 20_ (the "Effective Date"), between the State of Florida, Department of Transportation, an agency of the State of Florida (the "Department"), and Broward County, a political subdivision of the State of Florida ("County") (the "Sub-recipient") (each a "Party" and collectively, the "Parties"). **RECITALS** WHEREAS, the Department and the Sub-recipient on December 9, 2016 (date original Agreement entered) entered into a Interlocal Agreement ("Agreement"). WHEREAS, the Parties have agreed to modify the Agreement on the terms and conditions set forth herein. The Agreement is amended to increase the financial participation by the County and to extend the Department's maintenance responsibilities for a period of up to 12 months, which will allow adequate time for the County to procure their own contract for a new provider to operate and maintain the nine (9) traffic sensors installed at Port Everglades Jurisdictional Area (PJA). NOW THEREFORE, in consideration of the mutual covenants in this Amendment, the Agreement is amended as follows: 1. **Recitals.** The following Recitals are modified and incorporated into this Agreement: AGREEMENT, 2. TERM.: The term of this Agreement shall commence upon execution by the County and Department and shall continue until September 30, 2025, unless earlier terminated as set forth in this Amendment. X AGREEMENT, 6. OWNERSHIP, B.: The County shall be responsible for all future costs associated with the nine (9) traffic sensors that are left in-place when this amendment ends on September 30, 2025 or once the County has their own contract with a new provider in place; whichever is sooner.
