## Business Impact Estimate

Ordinance title/reference:

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO THE BROWARD REGIONAL EMERGENCY MEDICAL SERVICES ("EMS") COUNCIL; AMENDING SECTION 15-74 OF THE BROWARD COUNTY CODE OF ORDINANCES ("CODE"); RELATING TO COUNTY COMMISSIONER REPRESENTATION ON THE EMS COUNCIL; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE.

1. Summary of the proposed ordinance (must include statement of the public purpose, such as serving the public health, safety, morals, and welfare):

Chapter 15 of the Code establishes the membership composition of the Broward Regional Emergency Medical Services ("EMS") Council, which currently includes representatives of medical, fire rescue, hospital, emergency management, and other community

stakeholder entities, as well as a County Commissioner. The EMS Council was established to advise the Board of County Commissioners on matters relating to emergency medical services, trauma management, coordination of prehospital care, system performance, and other issues affecting public health, safety, and welfare;

The proposed Ordinance, if enacted, would amend Chapter 15 of the Code to add an alternate County Commissioner, nominated by the Mayor, to serve on the EMS Council. The alternate County Commissioner may attend the meetings but would not be counted toward a quorum or vote except when serving in place of the designated County Commissioner. The alternate County Commissioner would be exempt from the attendance, removal, and reappointment provisions of Section 1-233 of the Code.

2. Estimate of direct economic impact of the proposed ordinance on private, for-profit businesses in Broward County, including, if applicable:

It is estimated that there will be no direct economic impact on private, for-profit businesses in Broward County. There are no new charges, fees, or regulatory costs associated with the ordinance.
