The Broward Sheriff's Office supports this LETF request for the Airport Traffic and Pedestrian Equipment. The Fort Lauderdale - Hollywood International Airport is requesting the purchase of a speed trailer equipped with LPR cameras which will be used during proactive traffic enforcement as a deterrent in areas where excessive speeds are a concern. The purchase of six electric bicycles will assist in deputies covering more patrol areas throughout the airport. The speed trailer equipped with LPR cameras will assist with addressing excessive vehicle speed concerns, therefore keeping other travelers safe. The electric bicycles will assist deputies in covering more patrol areas throughout the airport, to ensure safety to travelers.


