The City of Fort Lauderdale is in receipt of a request for a non-vehicular access line (NVAL) amendment to the **– "Las Olas Del Mar I" Plat**, approved on July 18. 1989 by the City of Fort Lauderdale (Ordinance Number C-89-81) and approval by Broward County Planning Council on February 27, 1991 (114-MP-89). Developer is proposing to amend the existing nonvehicular access lines which was approved by the City of Fort Lauderdale on July 9, 2019, pursuant to DRC Case No. R18018 ("Site Plan") and July 18, 1989 pursuant to DRC Case No. 28-P-89 ("Plat"). The Site Plan is available at the Urban Design and Planning Department.

Within the applicant's request are: A sketch and legal description of the existing nonvehicular access lines is attached hereto as Exhibit "B". A sketch and legal description of the proposed nonvehicular access lines is attached hereto as Exhibit "C". Date for the revised sketch and legal description is April 10, 2024.

Pursuant to Section 47-24.5 of the City of Fort Lauderdale Unified Land Development Regulations, the City has reviewed the proposed NVAL amendment and has no objection to the request.

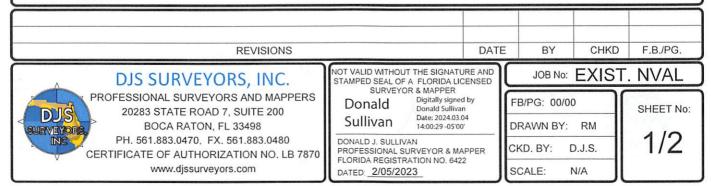

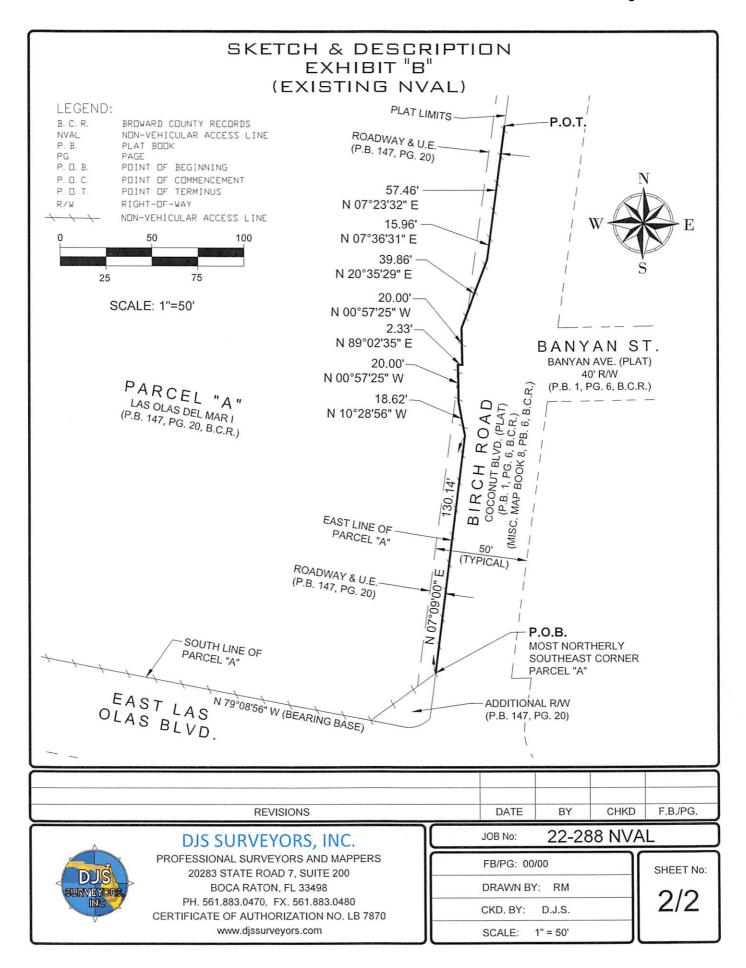
