Existing NVAL:	 Two (2) existing access openings on Dania Beach Boulevard: A 40-foot right turns out only access opening with centerline located approximately 25 feet west of the east plat limits. A 40-foot right turns in access opening with centerline located approximately 25 feet east of the west plat limits. This opening is restricted to Right Turns Out Only. 			
Proposed NVAL:	To close one existing access opening, to modify one existing access openings, and to create one new access opening on Dania Beach Boulevard 1. Close: A 40-foot access opening right turns out only with centerline located approximately 25 feet west of the east plat limits. 2. Modify: A 40 foot right turns in access opening, to a 30-foot right turns in access opening with centerline located approximately 28 feet east of the west plat limits, this opening will be restricted to Emergency Right Out Only. 3. Create: A 50-foot opening with centerline located approximately 46 feet west of the east plat limits. This opening is restricted to Right and Left Turns in and Right Turns out Only. 1. Access

Staff from the Highway Construction and Engineering Division and the Transit Division have reviewed this request and recommend **APPROVAL** subject to the conditions contained in the attached memorandum **(Exhibit 4)**.
