

RESOLUTION NO.

1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2 COUNTY, FLORIDA, PERTAINING TO PORT EVERGLADES FOREIGN-TRADE ZONE
3 NO. 25, TARIFF NO. 5 (“TARIFF”); AMENDING SECTION 42.29 OF THE BROWARD
4 COUNTY ADMINISTRATIVE CODE (“ADMINISTRATIVE CODE”); AMENDING FTZ
5 OPERATOR FEES; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE
6 ADMINISTRATIVE CODE, AND AN EFFECTIVE DATE.

7 WHEREAS, the Board of County Commissioners of Broward County, Florida
8 (“Board”), desires to amend Section 42.29 of the Broward County Administrative Code,
9 Exhibit 42.B, to revise Foreign-Trade Zone No. 25, Tariff No. 5, regarding FTZ Operator
10 Fees; and

11 WHEREAS, the Board has determined that the revisions are necessary and in the
12 best interests of Broward County, NOW, THEREFORE,

13 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
14 BROWARD COUNTY, FLORIDA:

15 Section 1. Foreign-Trade Zone No. 25, Tariff No. 5, as set forth in Section
16 42.29 and Exhibit 42.B of the Broward County Administrative Code, is hereby
17 amended in relevant part as follows:

20 **Item No. 407—FTZ Operator and Subzone Operator Fees.**

21 FTZ Operators and Subzone Operators shall be charged fees by Grantee as
22 follows:

23 (a) FTZ Operator Fees:

24 Application Fee..... ~~\$5,150~~ 2,500

25 Annual Fee (no production) ~~\$12,360~~ 7,000

26 Annual Fee (with production)..... ~~\$30,385~~ 9,000

27 Activation Fee..... ~~\$5,150~~ 4,000

28 Production Authorization Request Fee \$5,150 per request

29 Alteration Request Fee \$3,090 per request

31 Section 2. Severability.

32 If any portion of this Administrative Code Resolution is determined by any court to
33 be invalid, the invalid portion will be stricken, and such striking will not affect the validity
34 of the remainder of this Administrative Code Resolution. If any court determines that this
35 Administrative Code Resolution, in whole or in part, cannot be legally applied to any
36 individual, group, entity, property, or circumstance, such determination will not affect the
37 applicability of this Administrative Code Resolution to any other individual, group, entity,
38 property, or circumstance.

39 Section 3. Inclusion in the Broward County Administrative Code.

41 Administrative Code Resolution become part of the Broward County Administrative Code
