## RESOLUTION NO.

1 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD  
2 COUNTY, FLORIDA, PERTAINING TO ALTERATIONS TO VOTING PRECINCTS  
3 PURSUANT TO SECTION 101.001, FLORIDA STATUTES; DIRECTING THE COUNTY  
4 ADMINISTRATOR TO TRANSMIT A CERTIFIED COPY OF THIS RESOLUTION TO  
5 THE BROWARD COUNTY SUPERVISOR OF ELECTIONS; AND PROVIDING FOR  
6 SEVERABILITY AND AN EFFECTIVE DATE.

8 WHEREAS, in 2022, following the decennial census and with the recommendation  
9 and approval of the Broward County Supervisor of Elections, the Board of County  
10 Commissioners of Broward County, Florida ("Commission"), approved new voting  
11 precinct maps;

12 WHEREAS, with the benefit of new data from the 2024 primary and general  
13 elections and the March 2024 municipal elections, the Supervisor of Elections believes  
14 certain additional precinct alterations are beneficial to Broward County's electorate and  
15 in accordance with the applicable statutory requirements;

16 WHEREAS, Section 101.001(1), Florida Statutes, provides: "The board of county  
17 commissioners in each county, upon recommendation and approval of the supervisor [of  
18 elections], shall alter or create precincts for voting in the county"; and

19 WHEREAS, the Supervisor of Elections has recommended and approved the  
20 proposed alterations to the County's voting precincts as indicated in Exhibit A attached  
21 hereto, NOW, THEREFORE,

22 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
23 BROWARD COUNTY, FLORIDA:

24 Section 1. Based on the recommendation and approval of the Supervisor of  
25 Elections, and pursuant to Section 101.001(1), Florida Statutes, the Commission hereby  
26 approves the revised voting precincts as set forth in Exhibit A attached hereto.

27 Section 2. The Commission directs the County Administrator to provide a  
28 certified copy of this Resolution to the Supervisor of Elections.

29 Section 3. Severability.

30 If any portion of this Resolution is determined by any court to be invalid, the invalid  
31 portion will be stricken, and such striking will not affect the validity of the remainder of this  
32 Resolution. If any court determines that this Resolution, in whole or in part, cannot be  
33 legally applied to any individual, group, entity, property, or circumstance, such  
34 determination will not affect the applicability of this Resolution to any other individual,  
35 group, entity, property, or circumstance.

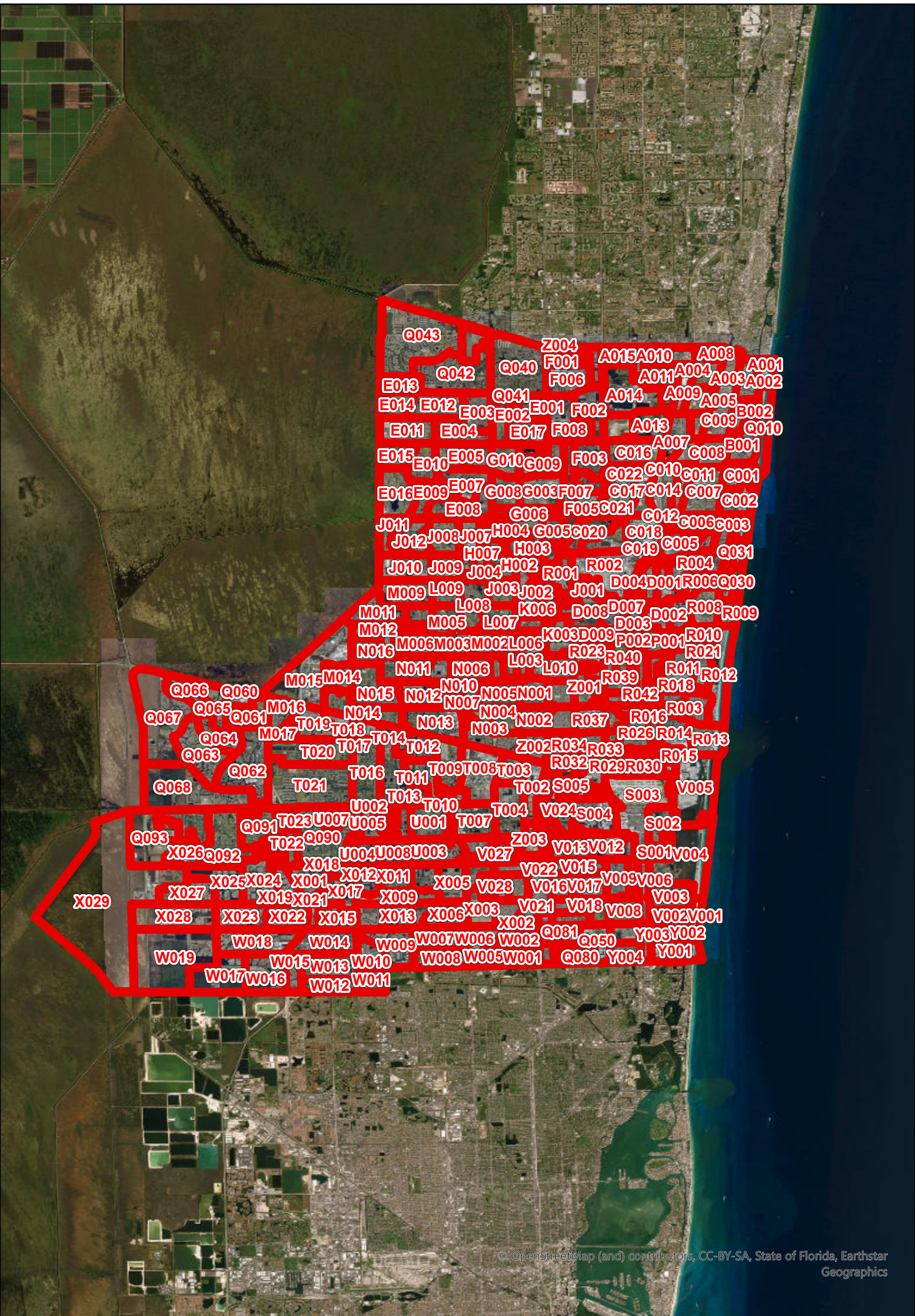
