9	WHEREAS, Section 2.06 of the Broward County Charter ("Charter") authorizes the
10	Broward County Board of County Commissioners ("Board") to propose amendments and
11	revisions to the Charter, subject to referendum of the general electorate;
12	WHEREAS, pursuant to Article VIII, Section 1 of the Florida Constitution, the voters
13	of Broward County have the constitutional right to determine the form of Broward County's
14	governmental structure, which includes the authority to increase or decrease the size of
15	the Board, establish Charter offices, and grant such powers to County Commissioners
16	and Charter officers as the voters deem appropriate;
17	WHEREAS, the Board desires to place an amendment to the Charter before the
18	voters at the November 8, 2022, General Election;
19	WHEREAS, the proposed amendment would change the Office of Mayor from
20	being Commission-elected on an annual basis to being a new countywide Charter
21	position elected on a partisan basis for a four-year term;
22	WHEREAS, Broward County's voters should have the opportunity to exercise their
23	right to decide whether the entire County should elect the Mayor of Broward County, with

such Mayor serving both as a representative of the Board of County Commissioners and a representative of the entirety of Broward County; and

WHEREAS, if the position of Broward County Mayor should ever become vacant for any reason, it is the will of the Board, and if this proposal is approved by the voters, the will of the residents of Broward County, that the position lapse until the next scheduled general election, and that pending such election the duties of Mayor be automatically transferred to and performed by the Vice-Mayor, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. Subject to an affirmative vote of the general electorate, Section 2.01 of the Charter of Broward County, Florida, entitled "Composition, redistricting, terms, qualifications, and compensation of members," is hereby amended, effective November 5, 2024 (except that Section 2.01 shall govern with respect to the qualifying for and the holding of the primary and general elections for Mayor in 2024), to read as follows:

Sec. 2.01. Composition, redistricting, terms, qualifications, and compensation of members.

The County Commission comprises the Legislative Branch of County government empowered to enact ordinances and resolutions, and to take action that is consistent with this Charter and that is in the best interest of the health, safety, and welfare of the County's citizens. For purposes of this section only, the term "Commissioner(s)" does not include the Mayor.

A. The County Commission shall be composed of nine (9) ten (10) members elected from single-member districts: nine (9) Commissioners elected from single-member districts; and one (1) Mayor elected at large. If the Office of Mayor ever lapses due to the existence of a vacancy, the County Commission shall be composed of nine (9) members from single-member districts until the Office of Mayor is recreated pursuant to Section 2.01.A(6) below.

- (5) Beginning with the 2024 General Election, the Mayor shall be elected at large, and shall serve for a term of four (4) years. The Mayor must be a County elector and resident.
- (6) If there is a vacancy (as defined by Article X, Section 3 of the Florida Constitution) in the Office of Mayor, the Office shall automatically lapse and remain lapsed until the next General Election cycle, at which point the Office shall be automatically recreated for a new four-year term, effective as of the date a Mayor elected in that General Election will take office, provided that if the Office has lapsed and no candidate for Mayor qualifies during the next General Election cycle, the Office shall remain lapsed until filled in a General Election cycle.
- B. Commissioners <u>and the Mayor</u> shall be elected on a partisan basis. The terms of office <u>for both Commissioners and the Mayor</u> shall begin on the Tuesday two (2) weeks following the day of the general election.
- C. Except as provided in this Section, election of Commissioners <u>and the</u>

 Mayor shall be as provided in Article VIII, Section 1(e), of the Florida Constitution.

- D. The Commissioners' salaries shall be determined and established in accordance with the general law of the State of Florida pertaining to compensation for Commissioners of non-charter counties. The Mayor's salary shall be \$220,000 for the 2025 fiscal year (prorated for the first year), and for every fiscal year thereafter shall increase or decrease on October 1 in accordance with the Consumer Price Index for All Urban Consumers (CPI-U), All Items, Miami-Fort Lauderdale-West Palm Beach, FL, calculated by the United States Department of Labor, or successor index, for the preceding calendar year as most recently reported by the United States Department of Labor. Commissioners and the Mayor shall only be reimbursed for expenses that are specifically approved by the County Commission, and when properly incurred on County business, in conformance with the laws of the State of Florida.
- E. Vacancies for Commissioners shall be defined and filled as provided by the laws of the State of Florida. Other than as a result of redistricting, any Commissioners who cease to reside in the District they represent shall be deemed to have vacated their office.
- F. During the Mayor's term in Office, the Mayor shall not earn or receive any earned income from any outside employment or as an independent contractor, and shall not serve as a compensated officer or director of any business entity. Nothing in this section in any way restricts the Mayor, to the extent not otherwise prohibited by law, from managing the Mayor's personal investments, including real estate and securities, whether individually held, jointly held, or as a fiduciary for an entity in which the Mayor has an ownership interest so long as the Mayor does not receive compensation or other remuneration for such management, or from participating in the activities of nonprofit charitable, religious, professional, or social organizations, including by serving on any

such organization's board of directors, provided the Mayor does not receive compensation or other remuneration from the organization.

Section 2. Subject to an affirmative vote of the general electorate, Section 2.02 of the Charter of Broward County, Florida, entitled "Term limitation for County Commissioner office," is hereby amended, effective November 8, 2024, to read as follows:

Sec. 2.02. Term limitation for County Commissioner office.

Effective with the terms of the Commissioners that commenced in November 2000, aAn individual shall not be eligible for election as a Commissioner for more than three consecutive four-year terms. Service as a Commissioner prior to the terms that commenced in November 2000 shall not be considered in applying the term limitations of this section. An individual shall not be eligible for election as Mayor for more than two consecutive four-year terms. Service of a two-year term, or any other partial term subsequent to November 2000, shall not be considered in applying the term limitation provisions of this section. For purposes of this section, the offices of Mayor and County Commissioner shall be considered separate offices, and service as the Mayor or County Commissioner shall not be considered when applying the term limitation provisions in this section to the other office.

Section 3. Subject to an affirmative vote of the general electorate, Section 2.03 of the Charter of Broward County, Florida, entitled "Commission election of Mayor and Vice-Mayor," is hereby amended, effective November 8, 2024, to read as follows:

Sec. 2.03. Commission election of Mayor and Vice-Mayor.

- A. The County Commission shall elect one (1) Commissioner to the position of Mayor by a majority vote. The election of the Mayor shall occur on an annual basis, during the County Commission's annual organizational meeting, which shall take place no earlier than the third Tuesday of each November and no later than the third Tuesday of each December. The County Commission may remove the individual from the position of Mayor by a majority vote. The Mayor may serve consecutive terms.
- B. Following the election of the Mayor, tThe County Commission shall elect a Commissioner to the position of Vice-Mayor by a majority vote <u>during the County Commission's annual organizational meeting</u>, which shall take place no earlier than the third Tuesday of each November and no later than the third Tuesday of each December. In the Mayor's absence, the Vice-Mayor shall have all the rights, privileges, and duties of the Mayor, except that the Vice-Mayor shall not be subject to Section 2.01.F. of the Charter and shall receive the same salary as other County Commissioners. The County Commission may remove the individual from the position of Vice-Mayor by a majority vote. The Vice-Mayor may serve consecutive terms.
- C: B. In the event the position of Mayor shall become vacant for any reason, the Vice-Mayor shall automatically become Mayor and serve as Mayor for the balance of the Mayor's term. The Commission shall elect a new Vice-Mayor who shall serve for the balance of the Mayor's term. If the Office of Mayor lapses pursuant to Section 2.01.A. of the Charter, all duties and powers of the Office arising under the Charter, Florida Statutes, Broward County Code of Ordinances, and the Broward County Administrative Code shall automatically be transferred on a temporary basis to the Vice-Mayor until such time as a Mayor is elected pursuant to Section 2.01 of the Charter. During the period in which the

Vice-Mayor has the duties and powers of the Office of Mayor, the Vice-Mayor's service shall be treated as continuous service as a Commissioner for purposes of term limitation provisions, Section 2.01.F of the Charter shall not apply, and the Vice-Mayor shall continue to receive the same salary as any other County Commissioner. If, for any reason, the duties of Mayor are being performed by anyone not elected in a countywide election to the position of Mayor, the Board of County Commissioners may transfer the Mayor's powers and duties to another member of the County Commission, and during such period such Commissioner's service shall be treated as continuous service as a Commissioner for purposes of term limitation provisions, Section 2.01.F of the Charter shall not apply, and the Commissioner shall continue to receive the same salary as the other County Commissioners.

- D. C. In the event If the position of Vice-Mayor shall become vacant for any reason, or the Vice-Mayor is performing the duties of Mayor pursuant to Section 2.03.B. of the Charter, the County Commission shall select a new Vice-Mayor who shall serve County Commissioner to perform the duties of Vice-Mayor for the balance of the Vice-Mayor's term or the period during which the Vice-Mayor is performing the duties of Mayor, whichever is shorter.
- D. Except for the temporary performance of the Mayor's duties pursuant to this section, if anyone is ever appointed to the Office of Mayor to fill a vacancy, or upon final judicial determination, including all appeals, that under Florida law any vacancy in the Office of Mayor must be filled by appointment, the amendment to the Broward County Charter establishing such Office of Mayor, approved November 8, 2022, shall be automatically, permanently, and irrevocably void in its entirety, and the structure of

Broward County Board of County Commissioners shall revert to the structure that existed as of November 7, 2022.

Section 4. Subject to an affirmative vote of the general electorate, Section 2.04 of the Charter of Broward County, Florida, entitled "Mayor–Duties and responsibilities," is hereby amended, effective November 8, 2024, to read as follows:

Sec. 2.04. Mayor-Duties and responsibilities.

The position Office of Mayor is created as a Charter Office in order to provide for an elected County representative who shall serve as the County's official representative and ceremonial dignitary, and who shall provide leadership on issues facing the County.

A. The Mayor shall be recognized as the head of the County by the Governor for purposes of military law, and for service of process. <u>Unless the County Commission</u> <u>designates another member of the County Commission</u>, <u>Tthe Mayor shall act as the County official designated to represent the County in negotiations with respect to agreements with other governmental entities, execute ordinances, resolutions, proclamations, and other legislative documents, and perform such other duties as specified in this Charter and as may be required by the County Commission, or as required by law.</u>

Section 5. A referendum election is called for the General Election on November 8, 2022, and at such other times as permitted for voting under Chapter 101, Florida Statutes, to determine whether the Broward County Charter should be amended to create a Mayor elected countywide.

Section 6. In accordance with Section 100.342, Florida Statutes, at least thirty (30) days' notice of the referendum election shall be published by the Broward County

prior to the week in which the referendum is to be held. The notice is hereby attached as Exhibit A and made a part hereof.

Section 7. Said referendum election shall be held between the hours of 7:00 a.m. and 7:00 p.m. on November 8, 2022, and at such other days and times as

Administrator in a newspaper of general circulation in Broward County. The publication

shall be made at least twice, including once in the fifth week and once in the third week

provided under applicable law, including for early voting as provided by Section 101.657, Florida Statutes, at the polling places established in Broward County. All registered and qualified electors in Broward County shall be eligible to vote in the referendum election. Vote-by-mail ballots and early voting access for the referendum shall be made available

as provided by law.

Section 8. The election boards consisting of the clerks and inspectors appointed to serve for the November 8, 2022, General Election are hereby appointed to serve in the referendum election in the manner provided by law.

Section 9. The Broward County Canvassing Board shall canvass the returns in said election and shall certify the results of the referendum election as provided by law.

Section 10. The County Administrator shall furnish a certified copy of this adopted Resolution to the Supervisor of Elections for Broward County promptly upon adoption by the Board.

Section 11. The title and summary of the referendum question to appear on the November 8, 2022, General Election, as embodied in this enabling Resolution, shall be as follows:

Section 12. Severability.

If any portion of this Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution, unless a Court finds that the Office of Mayor may or must be filled by appointment by the Governor of the State of Florida resulting from a vacancy or lapse in the Office, in which event it is the intent of the Board that this amendment shall be deemed invalid in its entirety. If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Resolution to any other individual, group, entity, property, or circumstance. If the County determines any part of the ballot statement, including the fiscal impact statement, is contrary to state law, the County Attorney is authorized to request that the Supervisor of Elections remove the applicable

NOTICE OF REFERENDUM ELECTION TO BE HELD ON TUESDAY, NOVEMBER 8, 2022, THE DATE OF THE GENERAL ELECTION, TO DETERMINE WHETHER TO AMEND THE BROWARD COUNTY CHARTER TO PROVIDE FOR A COUNTYWIDE ELECTED MAYOR.
