## RESOLUTION NO.

2 A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD  
3 COUNTY, FLORIDA, AUTHORIZING A DONATION IN THE AMOUNT OF  
4 FIVE THOUSAND DOLLARS (\$5,000) TO THE DELTA EDUCATION AND LIFE  
5 DEVELOPMENT FOUNDATION, INC.; DIRECTING THE COUNTY ADMINISTRATOR  
6 TO TAKE ALL ADMINISTRATIVE AND BUDGETARY ACTIONS NECESSARY TO  
7 IMPLEMENT THE DONATION; AND PROVIDING FOR SEVERABILITY AND AN  
8 EFFECTIVE DATE.

10 WHEREAS, Delta Education and Life Development Foundation, Inc. ("DELDF") is  
11 a nonprofit 501(c)(3), tax-exempt public service and community corporation with a  
12 mission to provide educational, charitable, and community services to the Broward  
13 County community;

14 WHEREAS, DELDF supports public service programs aimed at improving the  
15 quality of life of Broward County residents through education, cultural enrichment, and  
16 physical, emotional, and social well-being initiatives;

17 WHEREAS, annually, DELDF, in partnership with various community  
18 organizations, awards scholarships to qualified Broward County high school and college  
19 students to pursue higher education at institutions of their choice;

20 WHEREAS, in the past six years, DELDF, in support of its mission, has awarded  
21 over Three Hundred Thousand Dollars (\$300,000) in scholarships;

22 WHEREAS, numerous public and private individuals and entities have donated  
23 funds to Broward County ("County") designated to be donated by the County to a

24 scholarship fund in recognition of the retirement of former Broward County Administrator  
25 Bertha Henry;

26 WHEREAS, through Resolution No. 2022-082, the County previously donated  
27 Eighty-One Thousand Eight Hundred Ninety-Two Dollars (\$81,892) to DELDF in honor of  
28 Ms. Henry; and

29 WHEREAS, the Board desires to honor Ms. Henry and to support DELDF through  
30 an additional monetary donation, NOW, THEREFORE,

31 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
32 BROWARD COUNTY, FLORIDA:

33 Section 1. The Board finds that the donation to DELDF to support a scholarship  
34 fund in honor of Ms. Henry serves a public purpose and promotes public or community  
35 interest and welfare.

36 Section 2. The Board authorizes and approves the donation of  
37 Five Thousand Dollars (\$5,000) to DELDF in honor of Ms. Henry and to support DELDF's  
38 mission of improving the quality of life of Broward County residents through education,  
39 cultural enrichment, and physical, emotional, and social initiatives.

40 Section 3. The Board further directs the County Administrator to take all  
41 budgetary and other necessary actions to effectuate the donation to DELDF.

42 Section 4. Severability.

43 If any portion of this Resolution is determined by any court to be invalid, the invalid  
44 portion will be stricken, and such striking will not affect the validity of the remainder of this  
45 Resolution. If any court determines that this Resolution, in whole or in part, cannot be  
46 legally applied to any individual, group, entity, property, or circumstance, such
