

**NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Broward County Board of County Commissioners (the "Commissioners"), at its regularly scheduled meeting on November 15, 2022 at 10:00 a.m., or as soon thereafter as the same may be heard, at 115 South Andrews Avenue, Room 422, Fort Lauderdale, Florida 33301, for the purposes of receiving comments and hearing discussion concerning the issuance from time to time in one or more series pursuant to a plan of finance by the Michigan Finance Authority (the "Issuer") of its Hospital Revenue and Refunding Bonds (Trinity Health Credit Group) (the "Bonds"), a portion of the proceeds of which in an amount not to exceed \$20,000,000 shall be loaned by the Issuer to Trinity Health Corporation ("Trinity") and applied by Trinity to finance and refinance the Projects described herein (the "Holy Cross Projects") for Holy Cross Hospital, Inc. located at 4725 North Federal Highway, Fort Lauderdale, Florida 33308 ("Holy Cross").

The "Holy Cross Projects" consist of the financing or refinancing of additions and improvements to, and equipment for, hospitals or other health care facilities owned and operated by Holy Cross, including, but not limited to, renovations, improvements, equipment acquisitions, installation and equipping of capital improvements at the facilities located at the main campus of Holy Cross located at 4725 North Federal Highway, Fort Lauderdale, Florida. Proceeds of the Bonds will also be used to pay a portion of the costs of issuance of the Bonds. The Holy Cross Projects to be financed and refinanced with the proceeds of the Bonds are owned and operated by Holy Cross Hospital, Inc. and are located at the address set forth above.

The Bonds will not be a debt or liability of Broward County, the State of Florida or any political subdivision thereof, and neither Broward County, the State of Florida or any political subdivision thereof shall have any payment responsibility whatsoever in connection with the Bonds. The Bonds shall be special limited obligations of the Issuer, payable solely from payments to be made by Trinity.

A public hearing will be held pursuant to the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), at the above-referenced time and place in connection with the proposed issuance of the Bonds to finance and refinance the Holy Cross Projects described herein, at which time there will be an opportunity for persons to express their views on the foregoing.

Interested parties may appear in person at the November 15, 2022 meeting of the Commissioners and be heard with

respect to this public hearing item. Members of the public appearing in person must comply with any posted requirements regarding social distancing or facial coverings while in County buildings in compliance with the Broward County administrative policy.
