## RESOLUTION NO.

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, AUTHORIZING APPROPRIATION AND DISBURSEMENT OF U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES, HEALTH RESOURCES AND SERVICES ADMINISTRATION RYAN WHITE FUNDS IN THE AMOUNT OF \$2,390,342 FOR RYAN WHITE FISCAL YEAR 2023-2024 TO SPECIFIED SERVICE PROVIDERS FOR THE PROVISION OF HOUSING AND CARE SUPPORT SERVICES TO INDIVIDUALS LIVING WITH HIV IN BROWARD COUNTY; AUTHORIZING THE COUNTY ADMINISTRATOR TO EXECUTE NEW AGREEMENTS WITH THE SERVICE PROVIDERS AND TAKE ALL NECESSARY ADMINISTRATIVE AND BUDGETARY ACTIONS TO IMPLEMENT THE AGREEMENTS; AND PROVIDING FOR

WHEREAS, the U.S. Department of Health and Human Services, Health Resources and Services Administration ("HRSA") has previously awarded funds to Broward County under the *Ending the HIV Epidemic: A Plan for America – Ryan White HIV/AIDS Program* ("EHE") to reduce new HIV infections and expand the provision of services in Broward County to (i) individuals newly diagnosed with HIV, (ii) individuals living with HIV who are not engaged in care, and (iii) individuals with detectable amounts of HIV in their blood;

SEVERABILITY AND AN EFFECTIVE DATE.

21 WHEREAS, on October 15, 2019, the Board of County Commissioners of Broward 22 County, Florida ("Board"), approved the EHE grant application to HRSA for the award 23 period commencing on March 1, 2020, and ending on February 28, 2025; 24 WHEREAS, on April 14, 2023, HRSA approved the use of EHE grant funds 25 remaining from prior fiscal years (the "carryover funds") for Ryan White Fiscal Year 2023-26 2024 ("FY24"); 27 WHEREAS, the Board now desires to appropriate and disburse the carryover 28 funds to specified service providers for the provision of housing and care support services 29 to individuals living with HIV in Broward County; 30 WHEREAS, the Board further desires to authorize the Broward County 31 Administrator ("County Administrator") to execute new agreements with the service 32 providers specified in Attachment A; and 33 WHEREAS, the Board finds the services to be funded benefit the residents of 34 Broward County and serve a public purpose, NOW, THEREFORE, 35 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA: 36 37 Section 1. Authorized Appropriation and Disbursement. 38 The Board hereby authorizes appropriation and disbursement of funds in the 39 amount of Two Million Three Hundred Ninety Thousand Three Hundred Forty-two Dollars 40 (\$2,390,342) for FY24, as specified in Attachment A. 41 Section 2. Execution of New Agreements by the County Administrator.
