

# PROPOSED

ORDINANCE NO. 2020-

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO DESIGNATION OF URBAN WILDERNESS AREAS; AMENDING SECTIONS 25½-38, 25½-73, 25½-83, AND 25½-88 OF THE BROWARD COUNTY CODE OF ORDINANCES ("CODE") TO ADD ADDITIONAL LANDS TO FOUR (4) PREVIOUSLY DESIGNATED URBAN WILDERNESS AREAS; CREATING ARTICLES XVI THROUGH XXV OF CHAPTER 25½ OF THE CODE TO DESIGNATE TEN (10) URBAN WILDERNESS AREAS; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE.

(Sponsored by the Board of County Commissioners)

WHEREAS, Broward County has obtained ten (10) sites being proposed for designation as Urban Wilderness Areas within the Urban Wilderness Park System, known as Carpenter House Wilderness Area, Crescent Trail Wilderness Area, Deerfield Highlands Wilderness Area, Helene Klein Wilderness Area, Herman and Dorothy Shooster Wilderness Area, Highlands Scrub Wilderness Area, Pine Island Ridge Additions I and II Wilderness Area, Sands Parcel Wilderness Area, Saw Palmetto Wilderness Area, and West Creek Wilderness Area;

WHEREAS, Broward County has obtained parcels adjacent to four (4) previously designated Urban Wilderness Park System properties, known as Secret Woods Wilderness Area, Hillsboro Pineland Wilderness Area, Sheridan Street Wilderness Area, and Miramar Pineland Wilderness Area;

WHEREAS, the proposed sites and additional parcels comprise a combined total of 213.69 acres that, if approved, would bring the total acreage of designated Urban Wilderness Areas to 881.25;

1 WHEREAS, Chapter 25½, Article II, Broward County Code of Ordinances  
2 ("Code"), provides for the designation of wilderness areas within the Urban Wilderness  
3 Park System by ordinance, including a legal description, a dedication as a wilderness  
4 area, a designation of the type(s) of wilderness area being established, a general  
5 statement of preservation, and a statement of the management responsibilities; and

6 WHEREAS, the Broward County Urban Wilderness Advisory Board and the  
7 Broward County Parks and Recreation Division recommend that these new sites and  
8 additional parcels be designated as Urban Wilderness Areas,

9  
10 BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF  
11 BROWARD COUNTY, FLORIDA:

13 Section 1. Section 25½-38 of the Broward County Code of Ordinances is

4 Section 5. Articles XVI through XXV of Chapter 25½ of the Broward County  
5 Code of Ordinances are hereby created to read as follows:

7 **ARTICLE XVI. CARPENTER HOUSE WILDERNESS AREA**

8 **Sec. 25½-102. Establishment of wilderness area.**

9 The Carpenter House Wilderness Area, located in Broward County, Florida, is  
10 hereby established as a wilderness area pursuant to Section 25½-29, Broward County  
11 Code of Ordinances.

12 **Sec. 25½-103. Legal description.**

13 The legal description of the Carpenter House Wilderness Area is as follows:

14 Lots 8, 9, 10, and 11, Block 183, HOLLYWOOD CENTRAL BEACH, as  
15 recorded in Plat Book 4, page 20, of the Public Records of Broward County,  
16 Florida.

17 Said lands lying in the City of Hollywood, Broward County, Florida, containing 0.54  
18 acres, more or less.

19 **Sec. 25½-104. Dedication as wilderness area.**

20 Broward County's interest in the Carpenter House Wilderness Area as fee simple  
21 owner of the above-described real property is hereby dedicated to the public purpose of  
22 establishing and maintaining a wilderness area consistent with the provisions of this  
23 article.

24

1 **Sec. 25½-105. Type of wilderness area and statement of preservation.**

2 The Carpenter House Wilderness Area falls within all three (3) wilderness area  
3 types: biological, aesthetic, and scientific. Establishing the site as a wilderness area will  
4 implement the maintenance criteria necessary for preservation. The Carpenter House  
5 Wilderness Area contains a house built in the 1940s and a small area of dune ecosystem  
6 that transitions from coastal strand into impacted maritime hammock with low species  
7 diversity. Interior and exterior renovations of the house and conversion of the pool into a  
8 sea turtle pool have been completed, allowing for the house and pool to operate as a  
9 marine environmental education center. A 30-foot right-of-way located on the east side  
10 of the project site is managed by Broward County Parks and Recreation Division, and this  
11 area completes the transition of the dune ecosystem to the beach. The preservation of  
12 this site will allow a unique opportunity for research and the enjoyment of Broward County  
13 citizens who take advantage of the interpretative opportunities.

14 **Sec. 25½-106. Management responsibilities.**

15 The Broward County Parks and Recreation Division shall have responsibility for  
16 management of the Carpenter House Wilderness Area. Such management shall be  
17 directed to the preservation of the site as a wilderness area and shall be consistent with  
18 the rules and regulations governing the use of the area promulgated by the Urban  
19 Wilderness Advisory Board and adopted by the Board of County Commissioners pursuant

6 Broward County's interest in the Saw Palmetto Wilderness Area as fee simple  
7 owner of the above-described real property is hereby dedicated to the public purpose of  
8 establishing and maintaining a wilderness area consistent with the provisions of this  
9 article.

10 **Sec. 25<sup>1</sup>/<sub>2</sub>-145. Type of wilderness area and statement of preservation.**

11 The Saw Palmetto Wilderness Area falls within all three (3) wilderness area types:  
12 biological, aesthetic, and scientific. Establishing the site as a wilderness area will  
13 implement the maintenance criteria necessary for preservation. The parcel previously  
14 known as Site 18 is a small section of what was once part of a large expanse of pine  
15 flatwoods typical of north central Broward County. The parcel previously known as  
16 Site 451 was a disturbed area, cleared and filled through past development. South Florida  
17 slash pines (*Pinus elliotii* var. *densa*) and saw palmetto (*Serenoa repens*) dominate  
18 Site 18. Shrubs documented here include beautyberry (*Callicarpa americana*) and  
19 saltbush (*Baccharis halimifolia*), and understory plants include snowberry (*Chiococca*  
20 *alba*), rabbit bells (*Crotalaria rotundifolia*), cypress witchgrass (*Dichanthelium*  
21 *dichotomum*), and blackroot (*Pterocaulon pycnostachyum*). The parking lot, covered  
22 picnic tables, trailhead kiosk, storage building, and signage were constructed. The area  
23 around the parking lot (disturbed from previous development) was extensively planted  
24 with the following native flatwoods vegetation in 2014: slash pine, saw palmetto, gallberry

4 who take advantage of the interpretative opportunities.

5 **Sec. 25½-146. Management responsibilities.**

6 The Broward County Parks and Recreation Division shall have responsibility for  
7 management of the Saw Palmetto Wilderness Area. Such management shall be directed  
8 to the preservation of the site as a wilderness area and shall be consistent with the rules  
9 and regulations governing the use of the area promulgated by the Urban Wilderness  
10 Advisory Board and adopted by the Board of County Commissioners pursuant to  
11 Section 25½-22(a)(4), Broward County Code of Ordinances.

12 **ARTICLE XXV. WEST CREEK WILDERNESS AREA**

13 **Sec. 25½-147. Establishment of wilderness area.**

14 The West Creek Wilderness Area, located in Broward County, Florida, is hereby  
15 established as a wilderness area pursuant to Section 25½-29, Broward County Code of  
16 Ordinances.

17 **Sec. 25½-148. Legal description.**

18 The legal description of the West Creek Wilderness Area is as follows:

20 Parcel "A" and the West 115 feet of Parcel "B," HILLSBORO OFFICE PARK PLAT,  
21 as recorded in Plat Book 148, page 10, of the Public Records of Broward County,  
22 Florida.

23 (Folios: 484206110020 and 484206110022)

1 Also together with Parcel "B" of HILLSBORO OFFICE PARK PLAT, less the West  
2 215 feet, and together with all rights of Grantor over the East 100 feet of the West  
3 215 feet of said Parcel "B," as identified in the Warranty Deeds recorded in Official  
4 Records Book 16744, page 153, Official Records Book 30973, page 1461, and  
5 Official Records Book 38207, page 1111, of the Public Records of Broward  
6 County, Florida.

7 Said lands lying in the City of Coconut Creek, Broward County, Florida, containing  
8 7.43 acres, more or less.

9 **Sec. 25½-149. Dedication as wilderness area.**

10 Broward County's interest in the West Creek Wilderness Area as fee simple owner  
11 of the above-described real property is hereby dedicated to the public purpose of  
12 establishing and maintaining a wilderness area consistent with the provisions of this  
13 article.

14 **Sec. 25½-150. Type of wilderness area and statement of preservation.**

15 The West Creek Wilderness Area falls within all three (3) wilderness area types:  
16 biological, aesthetic, and scientific. Establishing the site as a wilderness area will  
17 implement the maintenance criteria necessary for preservation. The site is classified as  
18 mesic flatwoods with slash pine and saw palmetto associations. Common shrubby  
19 species include beautyberry, gallberry, wild coffee, staggerbush, and fetterbush. The C5  
20 canal bisects the site. The preservation of this site will allow a unique opportunity for  
21 research and the enjoyment of Broward County citizens who take advantage of the  
22 interpretative opportunities.

1 **Sec. 25½-151. Management responsibilities.**

2 The Broward County Parks and Recreation Division shall have responsibility for  
3 management of the West Creek Wilderness Area. Such management shall be directed  
4 to the preservation of the site as a wilderness area and shall be consistent with the rules  
5 and regulations governing the use of the area promulgated by the Urban Wilderness  
6 Advisory Board and adopted by the Board of County Commissioners pursuant to  
7 Section 25½-22(a)(4), Broward County Code of Ordinances.

8  
9 Section 6. Severability.

10 If any portion of this Ordinance is determined by any court to be invalid, the invalid  
11 portion will be stricken, and such striking will not affect the validity of the remainder of this  
12 Ordinance. If any court determines that this Ordinance, in whole or in part, cannot be  
13 legally applied to any individual, group, entity, property, or circumstance, such  
14 determination will not affect the applicability of this Ordinance to any other individual,  
15 group, entity, property, or circumstance.

16  
17 Section 7. Inclusion in the Broward County Code of Ordinances.

18 It is the intention of the Board of County Commissioners that the provisions of this  
19 Ordinance become part of the Broward County Code of Ordinances as of the effective  
20 date. The sections of this Ordinance may be renumbered or relettered and the word  
21 "ordinance" may be changed to "section," "article," or such other appropriate word or  
22 phrase to the extent necessary in order to accomplish such intention.
