SUBJECT: No CBE Goal for HWO Security Enhancements, Access Control and CCTV

Broward County Aviation Department (BCAD) is seeking a vendor to install security enhancements, gate access control, card readers, fiber optic cables, power cables, CCTV cameras, lighting and associated mounting poles and corresponding pole foundations. BCAD will fund twenty percent (20%) of the project. The Florida Department of Transportation (FDOT) will fund the remaining eighty percent (80%).

Effective July 1, 2015, Florida Statutes Title XVIII, Chapter 255, Section 0991 (ss.255.0991, FS), "*Contracts for construction services; prohibited local government preference*", prohibits the application of local preference policies for competitively solicited construction service contracts funded at fifty percent (50%) or more with state-appropriated funds. It states:

- "(2) For competitive solicitation for construction services...a state college, county, municipality, school district, or other political subdivision of the state may not use a local ordinance or regulation that provides a preference based upon:*
- (a) The contractor's maintaining an office or place of business within a particular local jurisdiction;*
 - (b) The contractor's hiring employees or subcontractors from within a particular local jurisdiction; or*
 - (c) The contractor's prior payment of local taxes, assessments, or duties within a particular local jurisdiction."*

Therefore, consistent with ss.255.0991(2), FS, the Office of Economic and Small Business Development (OESBD) is unable to establish a County Business Enterprise (CBE) goal on this project.

No CBE Goal for HWO Security Enhancements, Access Control and CCTV

This contract is not subject to the Broward County Workforce Investment Program.
