10	WHEREAS, the Broward County Board of County Commissioners ("Board")
11	enacted the Broward County Domestic Partnership Act of 1999 (the "Act"), whereby
12	registered domestic partners are afforded certain rights similar to those afforded spouses;
13	WHEREAS, pursuant to Section 161/2-158(c) of the Act, a registered domestic
14	partner has the same rights as would a spouse with respect to the making of health care
15	decisions for the patient or resident of a health care facility; and
16	WHEREAS, the Board wishes to clarify the Act to ensure it is consistent with
17	Florida law while still providing registered domestic partners the opportunity to make
18	health care decisions for their partners,

20	BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
21	BROWARD COUNTY, FLORIDA:

23	Section 1. Section 16½-158 of the Broward County Code of Ordinances is
24	hereby amended to read as follows:

Sec. 16½-158. Visitation to licensed facilities.

. . .

(c) A domestic partner of a patient or resident shall have the same rights as would a spouse or other family member with respect to visitation, and the making of. A domestic partner of a patient or resident shall be authorized to make health care decisions for the patient or resident, to the extent that a the patient or resident has specifically granted the domestic partner the authority to act as his or her health care proxy on the declaration of domestic partnership and has not executed a subsequent valid power of attorney for health care or a health care surrogate designation providing otherwise.

Section 2. <u>Severability</u>.

If any portion of this Ordinance is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Ordinance. If any court determines that this Ordinance, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Ordinance to any other individual, group, entity, property, or circumstance.

Section 3. <u>Inclusion in the Broward County Code of Ordinances.</u>

It is the intention of the Board of County Commissioners that the provisions of this Ordinance become part of the Broward County Code of Ordinances as of the effective date. The sections of this Ordinance may be renumbered or relettered and the word "ordinance" may be changed to "section," "article," or such other appropriate word or phrase to the extent necessary in order to accomplish such intention.
