

1 RESOLUTION NO. 2020-

2 A RESOLUTION OF THE BOARD OF COUNTY  
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,  
4 ORDERING THE BROWARD COUNTY VALUE ADJUSTMENT  
5 BOARD ("VAB") TO EXTEND THE ASSESSMENT ROLL  
6 PURSUANT TO SECTION 197.323, FLORIDA STATUTES;  
7 DIRECTING THE TRANSMISSION OF A CERTIFIED COPY OF  
8 THIS RESOLUTION TO THE VAB AND TO THE PROPERTY  
9 APPRAISER; AND PROVIDING FOR AN EFFECTIVE DATE.

7 WHEREAS, due to the volume of petitions filed before the Broward County Value  
8 Adjustment Board ("VAB"), not all hearings of the VAB will be completed before  
9 November 1, 2020;

10 WHEREAS, the Board of County Commissioners of Broward County, Florida (the  
11 "Board"), upon request of the Tax Collector of Broward County, Florida, is empowered  
12 under Section 197.323, Florida Statutes, to direct the VAB to extend the assessment roll  
13 upon a majority vote of the Board so that the tax bills can be mailed out;

14 WHEREAS, consistent with Section 3.06(A) of the Broward County Charter, all  
15 functions and duties of the Tax Collector were transferred to the Department of Finance  
16 and Administrative Services, and, more specifically, to the Director of the Records, Taxes  
17 and Treasury Division; and

18 WHEREAS, the Director of the Records, Taxes and Treasury Division of Broward  
19 County has requested that the VAB extend the assessment roll past November 1, 2020,  
20 through the completion of all VAB hearings, NOW, THEREFORE,

22 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
23 BROWARD COUNTY, FLORIDA:

1 Section 1. The Board, pursuant to Section 197.323, Florida Statutes, hereby  
2 orders that the 2020 assessment roll of Broward County, Florida, be extended through  
3 completion of all hearings by the Value Adjustment Board for Broward County, Florida,  
4 as required by Section 193.122, Florida Statutes.

5 Section 2. The Broward County Records, Taxes and Treasury Division is  
6 directed to mail out bills as expeditiously as possible in the manner prescribed by law.

7 Section 3. A certified copy of this Resolution shall be immediately transmitted  
8 to the Value Adjustment Board and the Broward County Property Appraiser.

9 Section 4. This Resolution shall become effective upon adoption.
