2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 AUTHORIZING APPROPRIATION AND DISBURSEMENT
5 OF FLORIDA DEPARTMENT OF CHILDREN AND
6 FAMILIES GRANT FUNDS IN THE AMOUNT OF \$420,162
7 TO PROVIDE EMERGENCY SHELTER SERVICES, RAPID
8 REHOUSING SERVICES, AND SUPPORTIVE SERVICES
9 TO FAMILIES AND INDIVIDUALS EXPERIENCING
10 HOMELESSNESS, AND ADMINISTRATIVE SERVICES
11 FOR FISCAL YEAR 2020-2021; AUTHORIZING THE
12 COUNTY ADMINISTRATOR TO TAKE ALL NECESSARY
13 ADMINISTRATIVE AND BUDGETARY ACTIONS TO
14 IMPLEMENT AGREEMENTS WITH CURRENT SERVICE
15 PROVIDERS; AND PROVIDING FOR SEVERABILITY AND
16 AN EFFECTIVE DATE.

17 WHEREAS, the Florida Department of Children and Families ("DCF") has awarded
18 Broward County three-year funding for four (4) local projects benefitting families and
19 individuals experiencing homelessness in Broward County, and for administrative
20 services to assist in increasing the capacity of the Continuum of Care;

21 WHEREAS, on June 11, 2019, the Board of County Commissioners of Broward
22 County, Florida ("Board"), provided Fiscal Year 2019-2020 DCF funds in the amount of
23 Four Hundred Twenty Thousand One Hundred Sixty-two Dollars (\$420,162) to specified
24 service providers for emergency shelter services, rapid rehousing services, and
supportive services to families and individuals experiencing homelessness, and for
administrative services (collectively, the "Services") for Fiscal Year 2019-2020;

WHEREAS, the Board desires to provide the second year of DCF funding in the
amount of Four Hundred Twenty Thousand One Hundred Sixty-two Dollars (\$420,162) to
the current service providers listed in Attachment A for the provision of the Services for
Fiscal Year 2020-2021;

1 WHEREAS, the Board desires to authorize the Broward County Administrator
2 ("County Administrator") to take all necessary administrative and budgetary actions to
3 implement the applicable agreements, which are subject to renewal under the same terms
4 and conditions; and

5 WHEREAS, the Board finds that the Services benefit the residents of Broward
6 County and serve a public purpose, NOW, THEREFORE,

8 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
9 BROWARD COUNTY, FLORIDA:

11 Section 1. Authorized Appropriation and Disbursement.

12 The Board hereby authorizes appropriation and disbursement of funds in the
13 aggregate amount of Four Hundred Twenty Thousand One Hundred Sixty-two Dollars
14 (\$420,162) to the service providers listed in Attachment A for Fiscal Year 2020-2021,
15 beginning July 1, 2020, and ending June 30, 2021.

16 Section 2. Administrative Action by the County Administrator.

17 The County Administrator is hereby authorized to take all necessary administrative
18 and budgetary actions to implement the renewed agreements with the current service
19 providers. Any material deviations from the approved agreement must be presented to
20 the Board for approval.

21 Section 3. Severability.

22 If any portion of this Resolution is determined by any court to be invalid, the invalid
23 portion will be stricken, and such striking will not affect the validity of the remainder of this
24 Resolution. If any court determines that this Resolution, in whole or in part, cannot be

1 legally applied to any individual, group, entity, property, or circumstance, such
2 determination will not affect the applicability of this Resolution to any other individual,
3 group, entity, property, or circumstance.

4 Section 4. Effective Date.

5 This Resolution is effective upon adoption.
