We also have the issue of traffic ever present in South Florida and this would add another 1600 vehicles to our overstretched road system. We also need to consider the environmental issue of ground contamination from arsenic and other chemicals used on the golf courses. This issue will affect current and future residents of the Woodlands, if not managed properly. The developer is proposing too many homes to be built on this property, which will destroy the character of this neighborhood. I understand that a Community Development District will be created and that the inherent costs will be passed on to the new home owners. How many millions of dollars will all of this cost them? So you might ask why should I care? It is my responsibility to care and assist my neighbors, whenever possible.

I decided to send this letter to all of you after learning that the Public Hearing on the Woodlands' Land Use Amendment has been continued to October 20, 2020.

Is worrisome that the Commission of the Broward County would even consider hosting an online quasi-judicial evidentiary hearing, to which the affected residents with legal standing cannot attend in person to deliberate candidly, in real time, about the impact to their quality of life, and to defend the irreplaceable natural resources that enrich their most valuable asset, the home they chose for the rest of their life.

How can our County government engage in an unfair arrangement that will block the resident's rights to a due process? How will we present evidence, cross-examine witnesses, rebut evidence and challenge impartiality without watching closely into your eyes, in the exact moment when the power given by the people could be used against us, to change the rules of engagement that we all have been adhering to for the last five decades?

The people of The Woodlands paid premiums for their homes, committed to a mortgage and to forever pay their fair share of taxes because they wanted the open green space, the long lived nature, the wildlife habitats and the golf recreation. I didn't see how this is going to be fair for the 800 Woodlands Homeowners to be a part of to participate in remotely and or on video. I am not capable of making a video and submitting it. This is going to lead to the suppressing of the Woodlands community and the surrounding communities and surrounding residence that are also affected parties in this matter. This is going to make a fair participation very hard, and if we can't witness everything LIVE as it happens, then how do we know everyone was fairly heard and fairly questioned when questioning is needed? There are attorneys for both sides, expert witnesses, affected parties that are wanting to speak, and people from the City of Lauderhill that are affected parties and would want to be heard. I don't see how this is going to be fair, normally (prior to Coronavirus) it would be at an open setting where all the County Commissioners could see the faces of all the affected residences even if they were not even going up to speak for 3 minutes. Now you're not going to see this affect community and people from the other outside communities that are affected and impacted by this. That's just not fair.

Prior to the Coronavirus Pandemic, I have gone to and participated at the 2 City of Tamarac Planning & Zoning Hearings, numerous City of Tamarac Commission Meetings which I have spoken out at, and also the City of Lauderhill Commission Meetings where I have spoken out 3 times. All times I have spoken out against the Rezoning of the Woodlands Community for numerous reasons. I also spoke out against it at the Broward County Planning and Zoning Hearing last year.

Now it seems the process is not going to be fair.

I have not had the Coronavirus. My mother and I reside in the same household; she is 88 years old now. I have had to take her to the doctors 10 times in the past month. The doctors have told us that if I become A Symptomatic Positive, she will die because of all her medical issues. We were told she is very high at risk, I am at risk because of my age and prior health problems. We reside at 6104 Orchard Tree Lane, Tamarac. My mother name is Sylvia Bronstein (her last name was Shapiro, but my father died in 1974 and she re-married in 1981 becoming Bronstein) and has been residing at this residence for 22 years.

It is very unfortunate the times we are living in today, and the Coronavirus Pandemic is still out there, it has not gone away. I would hope that the October 20, 2020 Broward County Commission Hearing would be postponed for a better time after all the concerns I have raised to you have been addressed. Without

that, I don't see how this Broward County Commission Hearing is going to be fair.
