If ISC has claimed a copyright for any of the documents or materials it produces under the term of its Agreement, ISC has agreed to grant Broward a non-exclusive license to use the copyrighted item(s) indefinitely, to prepare derivative works, and to make and distribute copies to the public, which license Broward agrees to grant to and share with Contributing Counties.

Contributing Counties acknowledge that ISC is an independent contractor and Broward County is not liable for any negligence on ISC's part.
