1 **RESOLUTION NO. 2021-**2 RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA. 3 PERTAINING TO HOLIDAYS; CREATING SECTION 14.197 OF THE BROWARD COUNTY ADMINISTRATIVE CODE 4 ("ADMINISTRATIVE CODE"); PROVIDING FOR **OBSERVANCE** AND EDUCATION OF JUNETEENTH 5 19"); AND PROVIDING FOR SEVERABILITY JUNE ÌNCLUSION´ÍN THE ADMINISTRATIVE CODE, AND AŃ 6 EFFECTIVE DATE. 7 (Sponsored by Commissioner Tim Ryan) 8 9 WHEREAS, on September 22, 1862, President Abraham Lincoln signed the Emancipation Proclamation, announcing that, effective January 1, 1863, all persons held 10 as slaves within any state then being in rebellion against the United States shall be 11 12 "forever free." Over two years later, on June 19, 1865, the Union Army informed enslaved 13 African Americans in Galveston, Texas, of their freedom from slavery and the end of the 14 Civil War; 15 WHEREAS, June 19, also known as Juneteenth, commemorates this event and celebrates the end of slavery in the United States, and therefore is an opportunity for all 16 17 Americans to celebrate freedom and equal rights; 18 WHEREAS, Juneteenth is recognized as a holiday in more than 45 states, 19 including Florida and the District of Columbia; and 20 WHEREAS, the Board of County Commissioners (the "Board") wishes to amend 21 the Broward County Administrative Code to add Juneteenth (June 19) as a day of 22 observance, celebration, and education, NOW, THEREFORE, 23 24 Words in struck-through type are deletions from existing text. 1 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF 2 BROWARD COUNTY, FLORIDA:

3 Section 1. Section 14.197 of the Broward County Administrative Code is hereby
4 created to read as follows:

14.197. Juneteenth Celebration Day.

June 19 is designated as Juneteenth Celebration Day, commemorating the end of
slavery and a celebration of freedom and equal rights. The County shall take the following
steps to commemorate Juneteenth:

(a) Support the continued celebration of Juneteenth countywide by means of
County-sponsored events to provide an opportunity for Broward County employees and
the general public to learn more about the history and experiences related to Juneteenth
that have shaped the United States; and

(b) Provide special programs and educational information about Juneteenth
through Broward County Libraries, Parks, and other Departments, Divisions, and Offices.

16 Section 2. <u>Severability</u>.

If any portion of this Administrative Code Resolution is determined by any court to
be invalid, the invalid portion will be stricken, and such striking will not affect the validity
of the remainder of this Administrative Code Resolution. If any court determines that this
Administrative Code Resolution, in whole or in part, cannot be legally applied to any
individual, group, entity, property, or circumstance, such determination will not affect the
applicability of this Administrative Code Resolution to any other individual, group, entity,
property, or circumstance.
