



**FIRST AMENDMENT TO AGREEMENT BETWEEN
BROWARD COUNTY AND THE CITY OF TAMARAC
FOR MAINTENANCE OF BUS SHELTERS**

This is the First Amendment to the Agreement (the "First Amendment") between Broward County (the "County") and the City of Tamarac, a municipal corporation located in Broward County, Florida, organized and existing under the laws of the state of Florida (the "Municipality") (collectively the "Parties").

RECITALS

A. The Parties entered into an Agreement dated August 16, 2011 (the "Agreement"), that provided for the installation and maintenance of bus stop improvements within the jurisdictional limits of the Municipality.

B. The Parties desire to enter this First Amendment to provide for bus stop improvements at seventy-nine (79) additional locations.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

1. Except as expressly modified herein, all terms and conditions of the Agreement remain in full force and effect. Amendments made to the Agreement by this First Amendment are indicated by use of strikethroughs to indicate deletions and underlining to indicate additions. Terms used herein but not defined herein shall have the meaning ascribed to such terms in the Agreement.
2. Exhibit A is revised as indicated in the attached Exhibit A.
3. The effective date of this First Amendment shall be the date of complete execution by both Parties. This First Amendment, together with the Agreement, represents the final and complete understanding of the Parties regarding the subject matter of the items addressed herein, and together with the Agreement, supersedes all prior and contemporaneous negotiations and discussions regarding that subject matter. There is no commitment, agreement, or understanding concerning the subject matter of this First Amendment or the Agreement that is not contained in this written document or the Agreement.
4. This First Amendment may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute one and the same agreement.
5. Each individual executing this First Amendment on behalf of a party hereto hereby represents and warrants that he or she is, on the date he or she signs this First Amendment, duly authorized by all necessary and appropriate action to

execute this First Amendment on behalf of such party and does so with full legal authority.



SECTION 3: The City Manager or his designee is hereby authorized to approve any renewal options and the extension of said acceptance of this Agreement as may be authorized by Broward County.


SECTION 5: All Resolutions or parts of Resolutions in conflict herewith are hereby repealed to the extent of such conflict.


