20	amended to read as follows:

- j. <u>i.</u> One citizen who represents employers within the jurisdiction; and
- k. <u>į.</u> One citizen who represents essential services personnel, as defined in the local housing assistance plan; One citizen who is actively engaged in the banking or mortgage banking industry in connection with affordable housing.

For purposes of this section, the term "resolution" includes a written agenda item that provides for the appointment of one or more persons to serve as members of the Committee and the approval of which item is recorded in the meeting minutes of the Board.

(2) If the Board, due to the presence of one or more conflicts of interest by or among prospective appointees or because of any other reasonable factor, is unable to appoint a citizen actively engaged in activities having connection with affordable housing, as described in subparagraphs a. - k. sections (c)(1) a. - i., the Board may appoint to the Committee a citizen engaged in the same activity but without regard to affordable housing.
