CBE Compliance Comments:

Chen Moore and Associates, Inc., Keith and Associates, Inc., Kimley-Horn and Associates, Inc., MARLIN Engineering, Inc., R.J. Behar & Company, Inc., and Stanley Consultants, Inc. submitted the required documentation in accordance with the solicitation's requirements and are compliant with the CBE program requirements.

At the time of bid submittal, HBC Engineering Company did not provide the required Letters of Intent (LOIs) and/or Application for Evaluation of Good Faith Effort to meet the 30% CBE requirement. HBC Engineering Company was given three (3) business days to provide LOI(s) and/or documentation demonstrating their good faith efforts to meet the goal. OESBD did not receive any documentation from HBC Engineering Company and therefore originally deemed the firm non-compliant with the CBE program requirements of this solicitation.

OESBD was informed by Purchasing on August 28, 2020, via email, that HBC Engineering Company submitted an LOI to Purchasing on July 27, 2020 as part of their response to a request made by Purchasing for financial documentation. After review with Purchasing, OESBD has determined that the LOI was submitted to Purchasing within the allotted three (3) business days. Based on the information provided, OESBD determines that the firm HBC Engineering Company is compliant with the CBE program requirements of this solicitation.
