If there are no registered programs for any type of work to be performed on the construction project and the Vendor selects a company-sponsored program, Vendor must provide a detailed

Prior to the County entering into a construction contract with Vendor, the County must receive documentation from Vendor verifying compliance with Section 26-10(a) of the Broward County Code of Ordinances.
