RESOLUTION **BOARD** OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA. VACATION REGARDING PETITION NO. 2021-V-05. VACATING A 25-FOOT DRAINAGE EASEMENT WITHIN TRACT B OF JACARANDA PARCEL 834 PLAT (PLAT BOOK 133, PAGE 28); AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, pursuant to a Notice of Public Hearing, duly and regularly advertised in accordance with law, a public hearing was held in the Commission Meeting Room 422. Broward County Governmental Center, located at 115 South Andrews Avenue, Fort Lauderdale, Florida, on October 19, 2021, to consider the advisability of renouncing and disclaiming the rights of Broward County ("County") and the public and to vacate and annul a 25 foot Drainage easement lying within Tract B of Jacaranda Parcel 834 Plat (Plat Book 133, Page 28), all included in the Official Records of Broward County, Florida, and generally located at 1301 Southwest 80 Terrace in the City of Plantation, Florida, said lands situate, being, and lying in Broward County, Florida, as described in Exhibit A, attached hereto; and

WHEREAS, after hearing all interested parties and determining that the proposed action will not materially interfere with the County road system or adversely affect the interests of the citizens of Broward County, and will not affect the ownership of or deprive any person of convenient access to his/her premises, in accordance with Section 177.101, Florida Statutes (as amended from time to time), it was determined that it would be in the best interest of all concerned to vacate and annul the rights of the County

and the public to and in the aforementioned land as described in Exhibit A, all situate, being, and lying in Broward County, Florida, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

### Section 1. Vacation and Annulment.

Pursuant to Section 177.101, Florida Statutes, said Board hereby vacates and annuls the rights of the County and the public to the land set forth in Vacation Petition No. 2021-V-05, as described in Exhibit A, all situate, being, and lying in Broward County, Florida.

### Section 2. Severability.

If any portion of this Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution. If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Resolution to any other individual, group, entity, property, or circumstance.
