

BROWARD COUNTY CULTURAL DIVISION GRANT AWARD AGREEMENT

This Broward County Cultural Division Grant Award Agreement ("Grant Agreement") is made and entered into by and between Broward County, a political subdivision of the State of Florida ("County") and Nova Southeastern University, Inc., on behalf of its Museum of Art Division, a nonprofit (not-for-profit) Florida corporation, ("Recipient"). County and Recipient are individually referred to as a "Party" and collectively as the "Parties".

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:
