Funds will be used by the Broward Sheriff's Office to purchase equipment and provide training for detention personnel to better protect inmates from sexual abuse through an Interlocal Agreement with the County. Grants Administration will provide oversight and monitoring of this grant. This is a two-year grant that was delayed by DOJ's new grant management system.
