Summary Explanation/Background

The Planning Council, as the Local Planning Agency (LPA) responsible for the Broward County Land Use Plan, considered the following proposed small scale amendment, PC 20-3, at its December 12, 2019, public hearing and **recommended approval, recognizing the City of Pompano Beach's General Obligation Bond Complete Street project for State Road A1A and its micro-transit program along Atlantic Boulevard, including not requiring a second Planning Council public hearing** (Vote of the Planning Council; Unanimous: 12-0; Blackwelder, Breslau, Brunson, Castillo, Fernandez, Gomez, Graham, Hardin, Maxey, Parness, Rosenof and Stermer):

AMENDMENT PC 20-3

Amendment to the Broward County Land Use Plan - City of Pompano Beach

3.5 acres of Recreation and Open Space and 0.7 acres of Community to Commerce

Approximately 4.2 acres; generally located north of Atlantic Boulevard, between Riverside Drive and State Road A1A.
