#### Requested Action

MOTION TO ADOPT budget Resolution No. 2020-275 within the General Fund transferring \$750,000 from the Broward Sheriff Office's Department of Detention reserve to the Department of Detention operating budget to pay invoices for inmate inpatient care costs incurred in Fiscal Years 2019 and 2020.

Transfers \$750,000 from the BSO Department of Detention reserve to the Department of Detention operating budget to pay invoices for inmate inpatient care costs incurred in Fiscal Years 2019 and 2020.

#### Previous Action Taken

As part of the Fiscal Year 2020 1<sup>st</sup> supplemental budget, the Board appropriated \$3,000,000 in the BSO Department of Detention reserve for inmate inpatient care costs. The Board subsequently adopted a budget motion transferring \$382,136 from the BSO Department of Detention reserve to the Department of Detention operating budget to pay invoices for inmate inpatient care costs on March

10, 2020.
