Clarke Mosquito Control Products, Inc., in the annual estimated amount of \$2,400,245 and authorize the Director of Purchasing to renew the contract for two one-year periods, for a total three-year potential amount of \$7,200,735. The initial contract period shall begin on the date of award and shall terminate one year from that date.

Motion B. In accordance with the Broward County Procurement Code, Section 21.31.a.4, Award Authority, Board approval is required for awards exceeding \$500,000 that includes a single bidder, rejection of apparent low bidder, or protested award.

Motion A. Approves the sole source designation with the authorized distributor.

Motion B. Provides a contract for mosquito control supplies for the Highway and Bridge Maintenance Division.

**Summary Explanation/Background**

THE PURCHASING DIVISION AND THE HIGHWAY AND BRIDGE MAINTENANCE DIVISION RECOMMEND APPROVAL OF THE ABOVE MOTIONS.

The Office of Economic and Small Business Development did not assign participation goals to this contract based on the sole source request (Exhibit 2).

Motion A: This action will approve the sole source designation to Clarke Mosquito Control Products, Inc. for the procurement of mosquito control supplies for the Highway and Bridge Maintenance Division.

This procurement is a crucial component to the safety and health of Broward County, for mosquito control supplies, such as the larvicide and mosquito test, and for the treatment of various areas in the County.

Motion B: The purpose of this contract is to furnish and deliver mosquito control supplies for the

Highway and Bridge Maintenance Division and other Broward County agencies that may have needs for these services.

The Highway and Bridge Maintenance Division has reviewed the bid submitted by Clarke Mosquito Control Products, Inc. and concurs with the recommendation for award (Exhibit 3).

Two vendor performance evaluations have been completed for Clarke Mosquito Control Products, Inc., with an overall rating of 3.98 out of a possible rating of 5.0. Copies of the vendor performance evaluation are available upon request.

On September 16, 2019, the Purchasing Division issued Request for Information (RFI) No. BLD2119687F1 to ascertain whether the mosquito products were specified as a sole source/sole brand by the Highway and Bridge Maintenance Division. The RFI yielded three responses, which indicated Clarke Mosquito Control Products, Inc. as the sole distributor of Anvil, Aqua Anvil, Natular products and Merus 3.0.

On October 8, 2019, the Director of Purchasing approved the Sole Source/Sole Brand Request (Exhibit 5).

Purchasing staff researched the prices submitted by the single bidder, Clarke Mosquito Control Products, Inc., and determined that the prices submitted are fair and reasonable by comparing this distributor's bid to other bids received by other governmental entities for like-kind products (Exhibit 4).

The bid posted on November 25, 2019 and opened on December 6, 2019; one bid was received with zero declinations.

The amounts referenced in this agenda item were rounded to the nearest whole dollar. Vendor payments will be based on the actual total bid amount. The bid tabulation reflects the actual amount of the award.
