## Previous Action Taken

#### Summary Explanation/Background

Section 177.142, Florida Statutes, authorizes local governments to change plat names by Ordinance when a determination is made that the name of a recorded plat contains a racial or ethnic slur. The Davie Chamber of Commerce Colored Subdivision Plat ("Plat") is recorded at Plat Book 19, Page 14, of the public records of Broward County, Florida. The proposed Ordinance finds that the name constitutes a racial slur and is demeaning to racial and ethnic groups and changes the Plat name to the "Davie Chamber of Commerce Subdivision."
