#### Summary Explanation/Background

THE OFFICE OF MEDICAL EXAMINER AND TRAUMA SERVICES RECOMMENDS APPROVAL.

This item is furtherance of the Commission Values of "Consistently delivering responsive, efficient, quality services to the public and internal customers" and "Cultivating...lifelong learning."

The Office of Medical Examiner and Trauma Services has, over the past six years, received similar grants for training, education, and equipment from the Department of Justice, National Institute of Justice (NIJ).

Currently, this office has requested, and has been approved to receive, \$2,760 through the State of Florida, Department of Law Enforcement, to obtain supplies and training for the Medical Examiner's staff, in order to enhance operations and training and improve the quality and timeliness of services.

The term of this grant is January 1, 2020 through December 31, 2020. The delay in processing was based upon funder requirements.
