The proposed Ordinance was prepared by the Office of the County Attorney as a result of

discussions by the Board of County Commissioners on June 16, 2020, and June 23, 2020.

**Summary Explanation/Background**

The proposed Ordinance supports the Board Goal to "Collaborate with public and private partners to find creative, equitable, and responsible solutions to systemic community problems."

This item would enable the Board to consider establishing a Racial Equity Task Force ("Task Force") to make recommendations to the Board to assist in identifying racial inequities in Broward County, developing policies aimed at eliminating racism, and working toward greater racial equity in Broward County.

The proposed Task Force would consist of nineteen (19) members, five (5) of whom would be nominated by a member of the Board, with the remaining members nominated by various community organizations and governmental entities.
