(DOJ), Office of Justice Programs (OJP), in the amount of \$124,973, from October 1, 2020 through September 30, 2022, for the purpose of recruiting qualified candidates for specialized training in forensic pathology to increase the number of physicians entering the field. Requesting the Mayor to direct the County Administrator to accept and sign the grant and take all necessary administrative and budgetary actions related to the Agreement, and authorizing the County Administrator to execute all amendments that do not exceed a total agreement amount of \$124,973. This agreement requires no County match. Match is not required but necessary for the completion of the project. Therefore, the non-federal share that has been incorporated in the approved budget is mandatory and subject to

audit.

THE OFFICE OF MEDICAL EXAMINER AND TRAUMA SERVICES RECOMMEND APPROVAL OF THE ABOVE ACTION.

This item supports the Board's value of "[C]onsistently delivering responsive, efficient, quality services to the public..." and attendant goal of "...addressing the lines of business and needs of the entire organization" by introducing physicians to the field of Forensic Pathology.

The National Institute of Justice (NIJ), Department of Justice has created this funding opportunity to address an extreme shortage of board-certified Forensic Pathologists in the United States. The NIJ may elect to provide additional funding in future years to awards made under this solicitation, through supplemental awards. The Office of Medical Examiner and Trauma Services has identified a
